AN ACT

| 2  | To enact R.S. 17:3351.16, relative to community and technical colleges; to provide relative |

| 7  | Be it enacted by the Legislature of Louisiana:  |
| 8  | Section 1. R.S. 17:3351.16 is hereby enacted to read as follows:                            |
| 9  | §3351.16. Louisiana Community and Technical College System; electronic and                  |
| 10 | digital textbooks and instructional materials; student charges                              |
| 11 | A. In an effort to reduce the cost of course materials to students and                      |
| 12 | provide a convenient means for students to purchase course materials in a single            |
| 13 | transaction in lieu of purchasing content separately, the Board of Supervisors              |
| 14 | of Community and Technical Colleges shall make every effort to ensure that                  |
| 15 | electronic and digital versions are available for all prescribed textbooks and              |
| 16 | other digital instructional materials and shall develop a program for the                   |
| 17 | encouragement and sale of electronic and digital textbooks and instructional                |
| 18 | materials.  |
| 19 | B. Beginning in the Fall 2011 semester and thereafter, the board shall:                     |
| 20 | (1) Direct institutions under its management to clearly communicate the                     |
| 21 | board's desire to increase the availability and accessibility of electronic and             |

| 5  | (2) Adopt such rules and regulations as are necessary for the sale and                        |
| 6  | distribution of electronic and digital textbook content, or fractions of electronic           |
| 7  | and digital textbook content, instructional materials and assessments.                        |
| 8  | C.(1) The board is authorized to charge a student who chooses to                              |
| 9  | purchase electronic and digital textbooks and other digital instructional                     |
| 10 | materials an amount not greater than the actual cost of such electronic and                   |
| 11 | digital textbooks and instructional materials.  |
| 12 | (2) The board may not charge the student for any administrative,                              |
| 13 | handling, or other related costs associated with the provision of electronic and              |
| 14 | digital textbooks and other digital instructional materials.                                  |
| 15 | (3) Notwithstanding any provision of law to the contrary, any monies                          |
| 16 | derived from such charges shall remain with the Louisiana Community and                       |
| 17 | Technical College System and shall not be deposited into the state general fund.              |
| 18 | Such monies shall be used exclusively to lower the costs of electronic and digital            |
| 19 | textbooks and other digital instructional materials for students.                             |
| 20 | (4) Nothing in this Section shall be construed to affect the terms of a                       |
| 21 | contract entered into by the board prior to the effective date of the Act which               |
| 22 | originated as Senate Bill No. 165 of the 2011 Regular Session of the Legislature              |
| 23 | of Louisiana.   |
| 24 | (5) Nothing in this Section shall be construed to supersede the                               |
| 25 | institutional autonomy or academic freedom of instructors, faculty members,                   |
| 26 | or academic departments involved in the selection of college textbooks and                    |
| 27 | other instructional materials.  |
| 28 | Section 2. This Act shall become effective upon signature by the governor or, if not          |
| 29 | signed by the governor, upon expiration of the time for bills to become law without signature |
| 30 | by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If  |

vetoed by the governor and subsequently approved by the legislature, this Act shall become
effective on the day following such approval.
