EXPENDITURE EXPLANATION

This bill may increase agency self-generated expenditures \$3,600 annually for the Greater Baton Rouge Port Commission.

Two additional members on the Commission would increase expenditures by \$3,600 annually if the board meets the maximum 24 days per year. (\$75.00 per diem x 24 regularly scheduled board meetings x 2 commissioners)

There may be additional increased expenditures if the commissioners receive per diems for meetings or activities during governor declared periods of emergency or for travel expenses for port-related conferences.

REVENUE EXPLANATION

There is no anticipated direct material impact on agency self-generated revenues as a result of this measure.
