**Purpose of Bill:** This measure creates the St. Helena Parish Elderly Service District as a political subdivision of the state of Louisiana and provides services to the elderly residents of St. Helena Parish. The proposed law authorizes the board to levy and collect ad valorem and sales taxes within the boundaries of the district. The sales and ad valorem tax would be subject to voter approval in accordance with the Louisiana Election Code. The district will enter into a cooperative endeavor agreement with the St. Helena Council on Aging in order to carry out the purpose of the district. The district will be governed by a five-member board and each member shall serve without compensation.

### EXPENDITURE EXPLANATION

**Local governmental expenditures may increase as a result of this measure.**

According to an official with the St. Helena Council on Aging, expenditures may increase as a result of this measure. Sales and ad valorem tax revenues will be used for the operations and programs to provide services for the elderly of St. Helena Parish. There may be other expenditures associated with the election.

### REVENUE EXPLANATION

**Local governmental revenues may increase by \$778,000 annually as a result of this measure.**

According to an official with the St. Helena Council on Aging, they anticipate a 1/2 percent sales tax will generate \$630,000 per year and a 3.55 property tax will generate \$148,000 per year which would total \$778,000 annually. This would be an even income for each year from 2012 to 2017.
