STUDENT/LOANS-SCHOLARSHIP: Extends TOPS eligibility for certain students who reenlist in the U.S. Armed Forces and maintain continuous active duty

1 AN ACT

2 To amend and reenact R.S. 17:3048.1(A)(1)(b)(i), (c)(i), (d)(i), and (4)(a)(iii), (B)(3)(a),  
3 (P)(1)(c), (2)(b), (3)(b), and (4)(b), (Q)(1)(d), and (V)(1)(c), relative to the Taylor  
4 Opportunity Program for Students; to provide for initial award eligibility and  
5 continuing eligibility for certain students who reenlist in the United States Armed  
6 Forces and maintain continuous active duty under certain circumstances; to extend  
7 the length of time required to claim or maintain an award for certain students on  
8 active duty under certain circumstances; to provide for applicability; to provide an  
9 effective date; and to provide for related matters.

10 Be it enacted by the Legislature of Louisiana:

11 Section 1. R.S. 17:3048.1(A)(1)(b)(i), (c)(i), (d)(i), and (4)(a)(iii), (B)(3)(a),  
12 (P)(1)(c), (2)(b), (3)(b), and (4)(b), (Q)(1)(d), and (V)(1)(c) are hereby amended and  
13 reenacted to read as follows:

14 §3048.1. Program awards; eligibility; amounts; limitations; funding; administration

15 A.(1) As part of the Louisiana Taylor Opportunity Program for Students, the  
16 state shall financially assist any student who enrolls on a full-time basis in a public  
17 college or university in this state or a regionally accredited independent college or  
18 university in the state that is a member of the Louisiana Association of Independent  
19 Colleges or Universities, hereafter in this Chapter referred to collectively as "eligible  
20 colleges or universities", to pursue an academic undergraduate degree or, as provided

1 by this Subsection, skill or occupational training as defined by the Board of Regents,  
2 including a vocational or technical education certificate or diploma program or a  
3 nonacademic undergraduate degree, and who meets the qualifications of  
4 Subparagraph (b), (c), or (d) of this Paragraph and all of the applicable following  
5 qualifications:

7 (b)(i) Has been certified as provided in Subsection D of this Section to have  
8 graduated from a public high school or a nonpublic high school which has been  
9 approved by the State Board of Elementary and Secondary Education, has a  
10 minimum cumulative grade point average of 2.50 calculated on a 4.00 scale, has a  
11 composite score on the 1990 version of the American College Test which is at least  
12 equal to or higher than the state's average composite score, rounded to the nearest  
13 whole number, reported for the prior year but never less than twenty or an equivalent  
14 concordant value on an enhanced or revised version of such test or on the Scholastic  
15 Aptitude Test, and, unless granted an exception for cause by the administering  
16 agency, has enrolled in an eligible college or university as a first-time freshman not  
17 later than the semester, excluding summer semesters or sessions, immediately  
18 following the first anniversary of the date that the student graduated from high  
19 school or, if the student joins the United States Armed Forces within one year after  
20 graduating from high school, has enrolled in an eligible college or university as a  
21 first-time freshman not later than the semester, excluding summer semesters or  
22 sessions, immediately following the fifth anniversary of the date that the student  
23 graduated from high school; however, effective for the 1996-1997 school year and  
24 thereafter, if, on or prior to the fifth anniversary of the date that the student graduated  
25 from high school, the student reenlists in the United States Armed Forces and  
26 maintains continuous active duty, the five-year period shall be extended to the  
27 semester immediately following the one-year anniversary of the student's separation  
28 from active duty service. As distinguished from all other students qualifying for this

1 program, a student who meets the requirements of this Subparagraph shall be the  
2 recipient of an "Opportunity Award" for the purposes of this program.

4 (c)(i)(aa) Has been certified as provided in Subsection D of this Section to  
5 have graduated from a public high school or nonpublic high school which has been  
6 approved by the State Board of Elementary and Secondary Education, has enrolled,  
7 unless granted an exception for cause by the administering agency, in an eligible  
8 college or university as a first-time freshman not later than the semester, excluding  
9 summer semesters or sessions, immediately following the first anniversary of the  
10 date that the student graduated from high school ~~or, if the student joins the United~~  
11 ~~States Armed Forces within one year after graduating from high school, has enrolled~~  
12 ~~in an eligible college or university as a first-time freshman not later than the~~  
13 ~~semester, excluding summer semesters or sessions, immediately following the fifth~~  
14 ~~anniversary of the date that the student graduated from high school, except as~~  
15 provided in Subitem (bb) of this Item, has achieved a minimum cumulative grade  
16 point average of 3.50 calculated on a 4.00 scale, and has a composite score on the  
17 1990 version of the American College Test of twenty-three or higher or an  
18 equivalent concordant value on any enhanced or revised version of such test or on  
19 the Scholastic Aptitude Test. As distinguished from all other students qualifying for  
20 this program, a student who meets the requirements of this Subparagraph shall  
21 receive and be recognized as the recipient of a "Performance Award" for the  
22 purposes of this program.

23 (bb) If the student joins the United States Armed Forces within one year after  
24 graduating from high school, has enrolled in an eligible college or university as a  
25 first-time freshman not later than the semester, excluding summer semesters or  
26 sessions, immediately following the fifth anniversary of the date that the student  
27 graduated from high school; however, effective for the 1996-1997 school year and  
28 thereafter, if, on or prior to the fifth anniversary of the date that the student graduates  
29 from high school, the student reenlists in the United States Armed Forces and

1 maintains continuous active duty, the five-year period shall be extended to the  
2 semester immediately following the one-year anniversary of the student's separation  
3 from active duty service.

5 (d)(i) Has been certified as provided in Subsection D of this Section to have  
6 graduated from a public high school or nonpublic high school which has been  
7 approved by the State Board of Elementary and Secondary Education with a  
8 minimum cumulative grade point average of 3.50 on a 4.00 scale and a score of  
9 twenty-seven or higher on the 1990 version of the American College Test or an  
10 equivalent concordant value on any enhanced or revised version of such test or on  
11 the Scholastic Aptitude Test, and, unless granted an exception for cause by the  
12 administering agency, has enrolled in an eligible college or university as a first-time  
13 freshman not later than the semester, excluding summer semesters or sessions,  
14 immediately following the first anniversary of the date that the student graduated  
15 from high school or, if the student joins the United States Armed Forces within one  
16 year after graduating from high school, has enrolled in an eligible college or  
17 university as a first-time freshman not later than the semester, excluding summer  
18 semesters or sessions, immediately following the fifth anniversary of the date that  
19 the student graduated from high school; however, effective for the 1996-1997 school  
20 year and thereafter, if, on or prior to the fifth anniversary of the date that the student  
21 graduated from high school, the student reenlists in the United States Armed Forces  
22 and maintains continuous active duty, the five-year period shall be extended to the  
23 semester immediately following the one-year anniversary of the student's separation  
24 from active duty service. As distinguished from all other students qualifying for this  
25 program, a student who meets the requirements of this Subparagraph shall receive  
26 and be recognized as the recipient of an "Honors Award" for the purposes of this  
27 program.

(4) To maintain continued state payment of an amount equal to tuition and other amounts pursuant to an award under this Chapter once enrolled in college a student shall meet all of the following:

(iii) If at any time a student fails to maintain the cumulative grade point average required for continuation in the program or as of the end of any semester or term during the academic year fails to make steady academic progress as defined by the administering agency, such student shall become ineligible for further payments.

Payments limited to those provided in Paragraph (A)(2) of this Section regardless of whether the originally granted award was an Opportunity, Performance, or Honors Award may be reinstated upon attainment of the grade point average required by this Paragraph for a student to maintain continued state payments once enrolled in college and the standards for steady academic progress as defined by the administering agency, provided that the student has maintained other continuation requirements and the period of ineligibility did not persist for more than two years from the date of loss of eligibility. If this two-year period is interrupted due to a student's active duty service in the United States Armed Forces, the two-year period shall be extended for a length of time equal to the student's active duty service, not to exceed four years, unless the student reenlists in the United States Armed Forces and maintains continuous active duty, in which case the period shall be extended for a length of time equal to the student's active duty service; or unless the student is granted an exception for cause by the administering agency.

(3) To maintain continued state payment of an amount equal to tuition pursuant to a TOPS-Tech Award once enrolled in an institution, a student shall meet all of the following:

1           (a) Make steady academic progress as defined by the administering agency  
2 toward completion of the requirements of the program in which enrolled earning not  
3 less than the minimum number of hours of credit required for full-time standing or  
4 the required number of hours needed to complete the program's requirements. If at  
5 any time a student fails to maintain the cumulative grade point average required for  
6 continuation in the program or as of the end of any term during the school year fails  
7 to make steady academic progress as defined by the administering agency, the  
8 student shall become ineligible for further payments. Payments may be reinstated  
9 upon attainment of the grade point average required for continuation of the original  
10 award and the standards for steady academic progress as defined by the  
11 administering agency, provided that the student has maintained other continuation  
12 requirements and the period of ineligibility did not persist for more than one year  
13 from the date of loss of eligibility. If this one-year period is interrupted due to a  
14 student's active duty service in the United States Armed Forces, the one-year period  
15 shall be extended for a length of time equal to the student's active duty service, not  
16 to exceed four years, unless the student reenlists in the United States Armed Forces  
17 and maintains continuous active duty, in which case the period shall be extended for  
18 a length of time equal to the student's active duty service; or unless the student is  
19 granted an exception for cause by the administering agency.

14 first-time freshman not later than the semester, excluding summer semesters or  
15 sessions, immediately following the fifth anniversary of the date that the student

21 application is received by the administering agency or, if the student joins the United  
22 States Armed Forces within one year after completing the home study program, has  
23 enrolled in a Louisiana public postsecondary institution as a first-time freshman not

25 following the fifth anniversary of the date that the student's initial application is  
26 received by the administering agency; however, effective for the 1996-1997 school  
27 year and thereafter, if, on or prior to the fifth anniversary of the date that the student

(c)(i) If graduating from a high school and unless granted an exception for cause by the administering agency, the student has enrolled in an eligible college or university as a first-time freshman not later than the semester, excluding summer semesters or sessions, immediately following the first anniversary of the date that the student graduated from high school or, if the student joins the United States ~~armed forces~~ Armed Forces within one year after the date that the student graduated from high school, has enrolled in an eligible college or university as a first-time freshman not later than the semester, excluding summer semesters or sessions, immediately following the fifth anniversary of the date that the student graduated from high school; however, effective for the 1996-1997 school year and thereafter, if, on or prior to the fifth anniversary of the date that the student graduated from high school, the student reenlists in the United States Armed Forces and maintains continuous active duty, the five-year period shall be extended to the semester immediately following the one-year anniversary of the student's separation from active duty service.

(ii) If a completer of a home study program approved by the State Board of Elementary and Secondary Education and unless granted an exception for cause by the administering agency, the student has enrolled in an eligible college or university as a first-time freshman not later than the semester, excluding summer semesters or sessions, immediately following the first anniversary of the date that the student completed a home study program approved by the State Board of Elementary and Secondary Education or, if the student joins the United States armed forces Armed

1        Forces within one year after the date that the student completed a home study  
2        program approved by the State Board of Elementary and Secondary Education, has  
3        enrolled in an eligible college or university as a first-time freshman not later than the  
4        semester, excluding summer semesters or sessions, immediately following the fifth  
5        anniversary of the date that the student completed a home study program approved  
6        by the State Board of Elementary and Secondary Education; however, effective for  
7        the 1996-1997 school year and thereafter, if, on or prior to the fifth anniversary of  
8        the date that the student completed the home study program, the student reenlists in  
9        the United States Armed Forces and maintains continuous active duty, the five-year  
10       period shall be extended to the semester immediately following the one-year  
11       anniversary of the student's separation from active duty service.

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

**Abstract:** Extends eligibility for TOPS awards for certain students who reenlist in the U.S. Armed Forces and maintain continuous active duty.

Present law provides for the Taylor Opportunity Program for Students (TOPS) as a program of merit scholarships (TOPS-Tech, Opportunity, Performance, and Honors awards) for first-time freshman attending La. public postsecondary institutions, regionally accredited independent colleges and universities in La., or certain out-of-state nonpublic postsecondary institutions who meet a specified GPA, ACT/SAT score, and core curriculum requirements, and certain other qualifications.

## INITIAL ELIGIBILITY

Present law requires that a student enroll in an eligible college or university as a first-time freshman not later than the semester, excluding summer semesters or sessions, immediately

following the first anniversary of the date that the student graduated from an eligible high school or completed the 12th grade level of a BESE-approved home study program.

Proposed law retains present law.

Present law further provides that if the student joins the U. S. Armed Forces within one year after graduating from high school, the student must enroll in an eligible college or university as a first-time freshman not later than the semester, excluding summer semesters or sessions, immediately following the fifth anniversary of the date of high school graduation or completion of the home study program.

Proposed law retains present law; however, effective from the 1996-1997 school year and thereafter, proposed law additionally provides that if, on or prior to the fifth anniversary of high school graduation or completion of the home study program, the student reenlists in the U.S. Armed Forces and maintains continuous active duty, the five-year period shall be extended to the semester immediately following the one-year anniversary of the student's separation from active duty service.

#### MAINTAIN CONTINUING ELIGIBILITY

Present law provides that, once enrolled in college, if at any time a student fails to maintain the cumulative GPA required for continuation in the program or as of the end of any semester or term during the academic year fails to make steady academic progress, such student becomes ineligible for further TOPS payments. Further provides that certain payments may be reinstated upon attainment of the required GPA, provided that the student has maintained other continuation requirements and the period of ineligibility did not persist for more than two years from the date of loss of eligibility for an Opportunity, Performance or Honors award. For a TOPS-Tech Award, provides that payments may be reinstated upon attainment of the required GPA, provided that the student has maintained other continuation requirements and the period of ineligibility did not persist for more than one year from the date of loss of eligibility. Proposed law retains present law.

Present law provides that if such period of ineligibility is interrupted due to a student's active duty service in the U.S. Armed Forces, the period will be extended for a length of time equal to the student's active duty service, not to exceed four years.

Proposed law generally retains present law, but extends the four-year length of time for a student who is on active duty, if the student reenlists in the U.S. Armed Forces and maintains continuous active duty, in which case the period will be extended for a length of time equal to the student's active duty service; or unless the student is granted an exception for cause by the administering agency.

Effective upon signature of governor or lapse of time for gubernatorial action.
