Provides relative to credits and overpayments for partnerships filing composite returns

Current law requires partnerships to file composite income tax returns and make composite payment of tax on behalf of any nonresident partners who do not agree to file an individual income tax return themselves. Overpayments of tax for nonresident partners entitles them to a refund or credit against future tax.

Proposed law allows the composite return to reflect any credits earned by the partnership and for overpayments of tax to be paid to the partnership for it to distribute to the respective nonresident partners.

**EXPENDITURE EXPLANATION**

Some one-time costs will likely be involved to modify tax forms and processes to allow for the taking or listing on the composite returns the credits earned by the partnership. These costs will have to be absorbed within the existing budget resources, unless incrementally funded. Tax processing savings may occur over time, as well, as the Department is able to refund overpayments to single partnership entities rather than to each nonresident partner that is eligible for a refund. These potential cost and savings are likely relatively minor.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. Currently, overpayments of tax by partnerships affected by this bill are refunded to the nonresident partners or allowed as a credit against future tax. This bill will allow overpayments to be refunded to the partnership, for it to distribute to the nonresident partners. Tax liabilities are not affected by the bill.
