4 proprietary or trade secret information which has been submitted to any state agency
5 with respect to a tax credit.6 (2) Nothing in this Section shall be construed to supercede any provision of
7 R.S. 47:1508 with respect to the confidentiality of taxpayer records.8 C."9 AMENDMENT NO. 12

10 On page 2, between lines 7 and 8, insert the following:

11 "D. For purposes of this Section, the terms "state agency" and "state office"
12 shall mean any office, department, board, commission, institution, or division within
13 the executive branch of state government. An agency which is required to generate
14 reports pursuant to this Section shall be an agency which is required by law to
15 administer the tax credit. Administration of a tax credit shall be evidenced by a legal
16 requirement or authorization to undertake any of the following actions for purposes
17 of administration of the tax credit:18 (1) Promulgate rules or regulations; in cases where more than one agency
19 has rulemaking authority, the report shall be prepared collaboratively.20 (2) Eligibility or qualifications.21 (3) Agency contract with an entity for purposes of a tax credit.22 (4) Oversight or substantial administrative functions for a tax credit when
23 the public purpose associated with the tax credit is within the core mission of the
