2 On page 1, line 4, after "prisons and" change "prisoners;" to "offenders;"

3 AMENDMENT NO. 2

4 On page 1, line 5, after "certain" and before "who" change "prisoners" to "inmates"

5 AMENDMENT NO. 3

6 On page 1, line 9, after "certain" and before "correspondence" change "prisoner" to "inmate"

7 AMENDMENT NO. 4

8 On page 1, at the end of line 10, after "certain" change "prisoner" to "inmate"

9 AMENDMENT NO. 5

10 On page 2, at the beginning of line 4, before "inmate" insert "death row"

11 AMENDMENT NO. 6

12 On page 2, line 23, after "defendant" and before "as provided" delete "convicted of a  
13 crime of violence"

14 AMENDMENT NO. 7

15 On page 3, delete lines 1 through 5 in their entirety and insert in lieu thereof:

16 "(4) "Defendant" means an offender who has been convicted of a capital offense  
17 and sentenced to death in accordance with the provisions of R.S. 15:567 through 571."

18 AMENDMENT NO. 8

19 On page 3, at the beginning of line 6, change "(6)" to "(5)" and at the beginning of line 7,  
20 change "(7)" to "(6)"

21 AMENDMENT NO. 9

22 On page 3, line 8, after "crime" delete "of violence"

23 AMENDMENT NO. 10

24 On page 4, line 14, after "convicted" delete the remainder of the line and at the beginning  
25 of line 15, delete "or nolo contendere,"

26 AMENDMENT NO. 11

27 On page 4, line 21 after "convicted" delete the remainder of the line and at the beginning of  
28 line 22 delete "contendere,"

1 AMENDMENT NO. 12

2 On page 6, line 14, after "**victim of**" and before "**or the**" delete "**a crime of violence**" and  
3 insert "**the defendant's crime**" and on line 15, after "**victim of**" delete the remainder of the  
4 line and insert "**the defendant's crime.**"

5 AMENDMENT NO. 13

6 On page 6, line 17, after "**a victim**" and before "**who died**" delete "**of a crime of violence**"  
7 and on line 18 after "**result of**" and before "**crime**" delete "**such**" and insert "**the**  
8 **defendant's**"

9 AMENDMENT NO. 14

10 On page 6, at the end of line 20, delete "**a**" and at the beginning of line 21, delete "**crime of**  
11 **violence or an attempted crime of violence**" and insert "**the defendant's crime**"

12 AMENDMENT NO. 15

13 On page 6, line 22, after "**apprehend**" delete the remainder of the line and delete line 23 in  
14 its entirety and insert in lieu thereof "**the defendant during the course of the crime.**"

15 AMENDMENT NO. 16

16 On page 6, at the beginning of line 27 delete "**a crime of violence or an attempted crime**  
17 **of violence**" and insert "**the defendant's crime**" and on line 28, after "**apprehend**" delete  
18 the remainder of the line and delete line 29 in its entirety and insert in lieu thereof "**the**  
19 **defendant during the course of the crime.**"

20 AMENDMENT NO. 17

21 On page 7, at the end of line 1, change "**upon**" to "**from**" and on line 2, after "**victim**" delete  
22 "**of a crime of violence**" and after "**result of**" change "**such**" to "**the defendant's**"

23 AMENDMENT NO. 18

24 On page 7, line 3, after "**support**" and before "**any**" change "**upon**" to "**from**" and on line  
25 4, after "**to prevent**" and before "**from**" delete "**a crime of violence or an attempted crime**  
26 **of violence**" and insert "**the defendant's crime**"

27 AMENDMENT NO. 19

28 On page 7, line 5, after "**apprehend**" delete the remainder of the line and delete line 6, in  
29 its entirety and insert in lieu thereof "**the defendant during the course of the crime.**"

30 AMENDMENT NO. 20

31 On page 7, line 10, after "**of a**" delete the remainder of the line and insert "**defendant's**  
32 **crime**" and on line 12, after "**of a**" and before "**crime**" insert "**defendant's**"
