**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Municipal, Parochial and Cultural Affairs  
to Original House Bill No. 934 by Representative Ligi

1 AMENDMENT NO. 1

2 On page 1, line 3, after "district" and before "to provide" delete "by Jefferson parish;" and  
3 insert "in the parishes of Jefferson and Orleans;"

4 AMENDMENT NO. 2

5 On page 1, line 13, after "district;" delete "Jefferson parish" and insert "parishes of Jefferson  
6 and Orleans"

7 AMENDMENT NO. 3

8 On page 1, delete lines 14 and 15 in their entirety and insert the following:

9 "A. (1) The governing authorities of the parishes of Jefferson and Orleans  
10 may each create, by ordinance, an automobile rental tax district, referred to in this  
11 Section as the "district". The district shall be a political subdivision of the state as  
12 defined in the Constitution of Louisiana."

13 AMENDMENT NO. 4

14 On page 1, at the beginning of line 16, change "(1)" to "(2)"

15 AMENDMENT NO. 5

16 On page 1, line 17, delete "parish." and insert "parish creating the district."

17 AMENDMENT NO. 6

18 On page 1, delete lines 18 and 19 in their entirety and insert the following:

19 "(3) The parish governing authority creating the district shall be the  
20 governing authority of the district."

21 AMENDMENT NO. 7

22 On page 2, at the beginning of line 1, delete "B.(1) The district may be" and insert "B.(1)(a)  
23 The district is"

24 AMENDMENT NO. 8

25 On page 2, line 5, after "indirectly." delete the remainder of the line and insert the following:

26 "(b) The tax shall be levied only after the question of its levy has been  
27 approved by a majority of the registered voters of the district who vote on the  
28 proposition authorizing the tax at an election held for that purpose in accordance  
29 with the Louisiana Election Code. The election on the question of the levy of the tax  
30 shall be held at the same time as a regularly scheduled election in the parish creating  
31 the district.

32 (c) The tax shall not apply to any automobile rented by"

2 On page 2, line 18, after "C." and before "The avails" insert "(1)"

3 AMENDMENT NO. 10

4 On page 2, between lines 23 and 24 insert the following:

5 "(2) The avails of the tax in Orleans Parish shall be used for road repairs and  
6 beautification projects."

7 AMENDMENT NO. 11

8 On page 2, line 24, after "The" and before "shall prescribe" delete "parish" and insert "parish  
9 governing authority creating the district"

10 AMENDMENT NO. 12

11 On page 2, line 25, after "parish" and before "and the" insert "that created the district"
