HOUSE BILL NO. 1091

BY REPRESENTATIVE FANNIN

REVENUE SHARING: Provides for revenue sharing distribution for Fiscal Year 2012-2013

1 AN ACT

2 To provide with respect to the Revenue Sharing Fund and the allocation and distribution
3 thereof for Fiscal Year 2012-2013; and to provide for related matters.

4 Be it enacted by the Legislature of Louisiana:

5 Section 1. For the purposes of this Act the following definitions shall apply and
6 obtain:

7 (a)(1) Unless otherwise provided herein, "tax recipient bodies" shall mean the city
8 of New Orleans, parish governing authorities, school boards, special taxing districts, and
9 other bodies which were eligible for reimbursement or payment from the Property Tax
10 Relief Fund prior to its abolition and repeal by Act 10 of the 1972 Extraordinary Session of
11 the Louisiana Legislature and any other taxing district listed in Sections 1(a)(3) and 1(a)(4)
12 or any other taxing district for any millage specified in Section 9(B) of this Act. In the
13 parish of Rapides, "tax recipient bodies" shall not include Red River Waterways. In the
14 parish of Lafourche, "tax recipient bodies" shall not include the Atchafalaya Basin Levee
15 District, the Lafourche Levee District, and Fresh Water District No. 1.

16 (2) "Tax recipient bodies" shall not include the millage levied by the various law
17 enforcement districts in the state in lieu of commissions as a result of Act 689 of the 1976
18 Regular Session of the Louisiana Legislature; however, law enforcement districts shall be
19 considered tax recipient bodies for any millage voted and levied for that purpose to the
20 extent specifically provided in Section 9(B) of this Act.

21 (3) "Tax recipient bodies" shall also mean those special taxing districts and other
22 bodies which were not eligible for reimbursement as provided in Section 1(a)(1) but which

1 had erroneously shared as a tax recipient body in the proceeds of Act 598 of the 1977
2 Regular Session and were subsequently determined by the state treasurer to be ineligible for
3 such participation under the provisions of Act 592 of the 1978 Regular Session. The

15 (4) "Tax recipient bodies" shall also mean the following special taxing districts and
16 other bodies which were not eligible for reimbursement as provided in Section 1(a)(1) and
17 which had never shared, except in the parishes of Bossier, East Baton Rouge, Ouachita and
18 Terrebonne, as a tax recipient body in the proceeds of state revenue sharing. The exclusive
19 listing of all such special taxing districts and other bodies is as follows:

- 29 (5)(a) In addition to the limitations hereinabove set forth, "tax recipient bodies" for
- 30 purposes of this Act shall be tax recipient bodies within the meaning of Article VII, Section

1 26 of the Constitution of Louisiana, limited solely to those taxes authorized prior to January
2 1, 1978, and any renewals thereof, or any millage authorized prior to January 1, 1978, but
3 not levied in full or part on the tax rolls. In Orleans Parish this limitation shall apply solely
4 to those taxes authorized and collected prior to January 1, 1978.

5 (b) "Population" shall mean that enumeration of persons within the state, its
6 parishes, and incorporated municipalities determined by the U.S. Census Bureau. Such
7 determination shall be the latest release by the U.S. Census Bureau before the start of the
8 current fiscal year. The population estimates shall have no effect on the distribution for the
9 fiscal year in which they are made but shall be utilized for purposes of this Act and for
10 distribution during the current fiscal year.

11 (c) "Homesteads" shall mean that enumeration of homestead exemption claims filed
12 with the assessors as determined by the Louisiana Tax Commission as of November fifteenth
13 of the current calendar year from the original tax rolls submitted to the commission prior to
14 any adjustments thereto.

15 (d) "Public school population" shall mean the enumeration of enrollments contained
16 in the Department of Education Annual Report for the preceding school year.

17 (e) "City of New Orleans", unless otherwise indicated herein, shall mean only the
18 city of New Orleans, the Orleans Levee District, the Sewerage and Water Board of New
19 Orleans, the Board of Assessors for Orleans Parish, and the Orleans Parish School Board and
20 reference in this Act to tax recipient bodies in the city of New Orleans shall refer only to the
21 aforesaid entities.

22 Section 2. The revenue sharing fund for the Fiscal Year 2012-2013 shall consist of
23 the sum of Ninety Million and No/100 (\$90,000,000.00) Dollars.

24 Section 3. The amount to be distributed annually to each parish from the revenue
25 sharing fund shall be the sum of (a) an amount equal to that percentage of eighty percent of
26 the total fund which is equal to the ratio which the population of the parish bears to the total
27 state population, and (b) an amount equal to that percentage of twenty percent of the total
28 fund which is equal to the ratio which the number of homesteads in the parish bears to the
29 total number of homesteads in the state. As used in this Section, the term "homesteads" shall
30 mean that enumeration of adjusted homestead exemption claims filed with the assessors as

1 determined by the Louisiana Tax Commission as of March thirty-first of the current calendar
2 year.

3 Section 4. Except as provided in Section 5, the state treasurer shall distribute the
4 funds herein allocated to the tax collectors of the respective parishes and to the city of New
5 Orleans.

6 Section 5. That portion of the fund for the parish of Ouachita allocated to the
7 Monroe City School Board shall be an amount which will reimburse said board, to the extent
8 available and subject to the provisions of Section 9(C) of this Act, for the taxes lost as a
9 result of homestead exemptions based on the tax rolls for the current calendar year and shall
10 be distributed directly to the city treasurer of the city of Monroe, who shall pay therefrom
11 the statutorily dedicated deductions for retirement systems. For the purpose of distribution
12 of the balance of the revenue sharing funds the state treasurer may use the amount listed on
13 the prior year Ouachita Parish tax rolls which were due the Monroe City School Board.

14 Section 6. Eleven and nine-tenths percent of all revenue sharing funds distributed
15 by the provisions of this Act, excluding such funds as are distributed directly to the city of
16 New Orleans and the amount listed on the prior year Ouachita Parish tax rolls which were
17 due the Monroe City School Board (\$1,286,005), shall form a special fund (\$9,781,703) to
18 be distributed as commissions to the tax collectors of the respective parishes, the city of New
19 Orleans excepted. Each such tax collector shall receive a percentage of such fund, based on
20 commissions received by him pursuant to Act 153 of the 1973 Regular Session, as provided
21 in Section 8 of this Act.

22 Section 7.A. Two and forty-four hundredths percent of all revenue sharing funds
23 distributed by the provisions of this Act, excluding such funds as are distributed directly to
24 the city of New Orleans and the amount listed on the prior year Ouachita tax rolls which
25 were due the Monroe City School Board (\$1,286,005), shall form a special fund
26 (\$2,005,660) to be distributed to the various retirement systems which were eligible for
27 payment pursuant to Act 153 of the 1973 Regular Session, as provided in Section 8 of this
28 Act for distribution to such retirement systems, and shall make due payment thereof to each
29 retirement system in the same proportion that the statutory deduction provided by law for
30 the system bears to the total statutory deductions provided by law for all such retirement

1 systems. For the purpose of distributing these retirement contributions, the state treasurer
2 may use the statutory deductions determined by the Public Retirement Systems Actuarial
3 Committee as per R.S. 11:103 for the previous calendar year.

4 B. The city of New Orleans shall make the deductions legally established for
5 retirement systems which were eligible for payment pursuant to Act 153 of the 1973 Regular
6 Session and shall make due payment in accordance with the statutory deductions provided
7 by law for all such retirement systems. Notwithstanding the above provisions the city of
8 New Orleans shall remit the following amounts for the indicated retirement systems for
9 Fiscal Year 2012-2013: Assessors' Retirement Fund, \$168,474; Clerks of Court Retirement
10 and Relief Fund, \$137,015; District Attorneys' Retirement System, \$67,281; Registrars of
11 Voters Employees' Retirement System, \$64,443; Sheriffs' Pension and Relief Fund, \$55,762.

12 Section 8. The respective percentages to be used in calculating tax collectors'
13 commissions and retirement system distributions shall be as follows:

19 Section 9. All remaining funds shall be allocated and distributed as follows:

20 A. Subject to the provisions of Subsection B of this Section and except as provided
21 by Section 5, the tax collector of each parish and the city of New Orleans shall allocate and
22 distribute, within fifteen days after receipt thereof, to the tax recipient bodies within his
23 jurisdiction an amount available after commissions and deductions which is necessary to
24 offset losses attributable to homestead exemptions. In any parish which had excess funds
25 in 1977, the amount available for the reimbursement of homestead exemption losses shall
26 be limited to the amount used for that purpose in 1977, adjusted by the percentage by which
27 the number of homesteads in the parish increased or decreased from 1977 to 2011, together
28 with any additional taxing bodies or millages authorized to participate on the same pro rata
29 basis under the provisions of Section 1(a)(3), Section 1(a)(4), and Section 9(B) of this Act.
30 This restriction shall not apply to the parish of East Carroll and to parishes in which there

1 were no excess funds in 1977. However, in the city of New Orleans the amount available
2 for the reimbursement of homestead exemption losses shall be limited to the amount used
3 for that purpose in 1977, except that the amount distributed to the Orleans Levee District
4 shall be limited solely to the amount used for the reimbursement of homestead exemption
5 losses in 1977 on its two mill tax. The remaining amount shall be adjusted by the percentage
6 by which the number of homesteads in the city of New Orleans increased or decreased from
7 1977 to 2009, together with any additional taxing bodies or millages authorized to participate
8 on the same pro rata basis under the provisions of Section 9(B) of this Act.

9 B. For purposes of this Subsection only, tax recipient bodies shall mean and include
10 any recipient of funds hereunder, but limited solely to such specified disbursements. The
11 millages listed are included solely as an identification aid for administrative purposes and
12 the new tax approved by the electorate shall be eligible for distribution hereunder, regardless
13 of fluctuations in millage caused by adjustments for reassessment or other purposes. In no
14 event shall any amount be deemed available within the meaning of Article VII, Section 26
15 of the Constitution of Louisiana to reimburse losses attributable to homestead exemptions
16 for taxes authorized after January 1, 1978, and any renewals thereof, with the following
17 basic exceptions:

18 (1) In the parish of Sabine, all millages listed on the tax roll, except the sheriff's
19 original millage, shall share on a pro rata basis.

20 (2) In the parish of DeSoto, all school board taxes authorized after January 1, 1978
21 and prior to the convening of the 1979 Regular Session, the 7 mill parishwide school tax
22 authorized May 2, 1987, the 37 mill school special tax authorized October 24, 1987, the
23 assessor's original millage, the maintenance taxes for Fire Protection Districts Nos. 1, 5, 8,
24 and 9 prior to 1990, the 7 mill tax authorized in 1994 for Fire District #2, the additional 8.37
25 mill tax authorized on November 7, 1978 for the parish law enforcement district, the 1 mill
26 tax authorized April 5, 1997 for Water District #1, the 3 mills tax authorized November 21,
27 2002 for the parish library, and the 1 mill tax authorized July 16, 1994 for the
28 Communications District 911 System, shall share on a pro rata basis with all other tax
29 recipient bodies in the parish. The parish road maintenance tax which lapsed in 1983 and

1 which was reauthorized at 5 mills in 1984 shall share on a pro rata basis with all other tax
2 recipient bodies in the parish.

3 (3) In the parish of Bossier, after full reimbursement of all taxes authorized prior to
4 May 1, 1978 to all other tax recipient bodies in the parish including the additional 3 mills
5 authorized on April 5, 1980 for the law enforcement district and the assessor's original
6 millage, the following new millages shall be reimbursed to the extent available:

7 School Board District 13--11.63 mills/September 16, 1978

8 School Board District 3--15.1 mills/September 16, 1978

9 (4) In the parish of Grant, all new millages authorized prior to January 1, 1989, the
10 10.9 mill tax authorized January 16, 1999 for the library, the millage authorized October 7,
11 1989 for Fire District No. 1, the 15 mill tax authorized in 1995 for Fire District #3, the
12 additional mills for the law enforcement district and the assessor's original millage, but
13 excluding bond millages, shall share on a pro rata basis with all other tax recipient bodies
14 in the parish.

15 (5) In the parish of Webster, after full reimbursement of all taxes authorized prior
16 to January 1, 1978 to all other tax recipient bodies in the parish and the assessor's original
17 millage, the following new millages shall be reimbursed to the extent available:

18 Doyline School District No. 7--33.32 mills/August 1, 1979

19 Consolidated School District No. 3--10.51 mills/June 1, 1978

20 Minden School District No. 6--32.9 mills/May 1, 1980

21 Parish Library--12 mills/November 2004

22 (6) In the parish of Vernon, all taxes authorized after January 1, 1978, including the
23 additional 7 mills authorized on April 4, 1981 for the law enforcement district, but excluding
24 the sheriff's original millage, shall share on a pro rata basis with all other tax recipient bodies
25 in the parish.

26 (7) In the parish of East Baton Rouge, the B.R.E.C. Maintenance and Operation and
27 Capital Improvement millages shall be limited to a total of 5.44 mills.

1 (8) In the parish of Lafourche, the total parish allocation, excluding the tax
2 collector's commission and the retirement systems' deductions shall form a special fund to
3 be distributed as follows:

4 Parish Council -57.40%

5 School Board - 27.25%

6 South Lafourche Levee District - 2.95%

7 Port Commission - 2.06%

8 Assessor - 3.32%

9 Bayou Lafourche Fresh Water District - 2.82%

10 North Lafourche Levee District - 4.20%

11 Provided, however, that of the funds distributed to the Bayou Lafourche Fresh Water
12 District in any state fiscal year, no less than Ten Thousand (\$10,000) Dollars shall be used
13 for the abatement of water hyacinth and other noxious vegetation within the jurisdiction of
14 the district in Lafourche Parish.

15 (a) Of the amount distributed to the parish the following allocations shall be made:

17 Drainage District No. 1 - 0.90%

18 Drainage District No. 5 - 0.65%

19 Fire District No. 1 - 0.57%

20 Fire District No. 2 - 0.59%

10 (b) The amount distributed to the school board shall be allocated as follows:

13 (9) In the parish of Calcasieu, the total parish allocation, excluding the tax collector's
14 commission and the retirement systems' deductions, shall form a special fund to be
15 distributed as follows:

- 16 Police Jury--48.5%
- 17 School Board--29.4%
- 18 Sheriff--11.9%
- 19 Police Jury--5.0% to be distributed to the district attorney
- 20 Lake Charles Harbor and Terminal District--2.8%
- 21 Assessor--2.3%
- 22 Vinton Harbor and Terminal District--0.1%.

23 (10) In the parish of Iberville, the library's 1996 millage shall be limited to 2.9 mills.

24 (11) In the parish of St. Bernard, the assessor's millage shall be limited to 1.47 mills.

25 (12) In the parish of Livingston, the library's 1995 millage shall be limited to 3.48
26 mills, the assessor's millage shall be limited to 2.56 mills, and the Juvenile Detention
27 Center's 1995 millage shall be limited to .44 mills, the #2 Fire District's millage shall be
28 limited to .81 mills, the #8 Fire District's millage shall be limited to 1.91 mills, and the #9
29 Fire District's millage shall be limited to 1.96 mills.

1 (13) In the parish of Assumption, the total parish allocation, excluding the tax
2 collector's commission and the retirement systems' deductions, shall form a special fund to
3 be distributed as follows:

4 Law Enforcement District - 30.77%

5 Police Jury - 30.25%

6 School Board - 28.72%

7 Assessment District - 10.26%

8 (14) The following new millages shall share on a pro rata basis with all other tax
9 recipient bodies in their respective parishes:

24 outstanding bonded indebtedness of such tax recipient body. In the parish of Livingston the
25 millage authorized in 1975 for the parish health unit shall share as an operation and
26 maintenance millage. In the parish of Avoyelles, the Ward 7 School District Construction
27 Tax and the Ward 10 School District Construction Tax shall each share as an operation and
28 maintenance millage. In the parish of DeSoto, the 150 mills authorized for School District
29 #2 shall share as an operation and maintenance millage. In the parish of East Baton Rouge,
30 the BREC Capital Improvement Tax shall share as an operation and maintenance millage.

1 Bond millages may share in the parish of Sabine; however, if there are no excess funds those
2 millages levied for operation and maintenance of those taxing districts eligible for
3 reimbursement shall have priority for reimbursement to the extent that funds are available.
4 In the parish of Bossier, bond millages and operation and maintenance millages shall share
5 on a pro rata basis and the school bonds listed in Section 9(B)(3) shall share as provided
6 therein.

7 (3) In the parish of St. Tammany, the parish governing authority shall make
8 available out of its allocated funds a sufficient amount for the operation and maintenance of
9 the food stamp offices and the service office for veterans established under R.S. 29:261. In
10 the parish of St. Tammany, the parish governing authority shall make available out of its
11 allocated funds five thousand dollars for the St. Tammany Humane Society. In the event of
12 any decrease in the state's appropriated portion of the salaries of the St. Tammany Parish
13 Registrar of Voters Office, the parish governing authority shall make available out of its
14 allocated funds a sufficient amount to replace such state funds, not to exceed \$15,537.58.
15 Of the funds allocated within the parish of St. Charles, thirty thousand dollars shall be
16 distributed to the St. Charles Department of Community Services to be used for the
17 operation of an outreach program at the St. Rose Community Center. Of the funds allocated
18 within the parish of Acadia, \$180,000 shall be distributed to the law enforcement district.

19 Section 10. In the event the distribution to the tax collector in each parish and to the
20 city of New Orleans is more than the amount necessary to satisfy the requirements of
21 Sections 6 and 7 of this Act and to reimburse all tax recipient bodies as set forth in Section
22 9 of this Act, then the city of New Orleans and the tax collector in each parish, within fifteen
23 days after receipt thereof, shall distribute such remaining excess amount as follows, except
24 as otherwise provided in Subsection D of this Section:

25 A. The portion of the excess equal to the ratio that the parish public school
26 population bears to the total population of the parish shall be allocated and distributed to the
27 respective city and parish school boards in the parish proportionate to the public school
28 population of each.

29 B. The next portion of the excess remaining after allocation and distribution to the
30 school boards, equal to the ratio that the total population of all incorporated areas in the

1 parish bears to the total parish population, shall be allocated and distributed to the respective
2 incorporated municipalities of the parish proportionate to the respective population of each.

3 C. The remaining portion of such excess, if any after allocation and distribution to
4 the school boards and incorporated areas of a parish, shall be allocated and distributed to the
5 parish governing authority.

6 D. For purposes of this Subsection only, "tax recipient bodies" shall mean and
7 include any recipient of excess funds hereunder. In the following parishes the tax collector
8 thereof, or in Orleans Parish, the city of New Orleans, within fifteen days after receipt
9 thereof, shall distribute such excess amount as follows:

10 (1) In the parish of Plaquemines, one hundred percent thereof to the parish
11 governing authority.

12 (2) In the parishes of Cameron, St. Charles, and St. John the Baptist, seventy-five
13 percent thereof to the parish governing authority, and twenty-five percent thereof to the
14 parish school board.

15 (3) In the city of New Orleans, seventy percent thereof to the city of New Orleans
16 and thirty percent thereof to the Orleans Parish School Board.

17 (4) In the parish of Jefferson, sixty percent thereof to the parish governing authority,
18 twenty-five percent thereof to the parish school board, and fifteen percent thereof to the
19 incorporated municipalities in the parish, to be distributed to such incorporated
20 municipalities pro rata on a population basis. However, no less than twenty-five percent of
21 the funds distributed to the parish governing authority in this Paragraph shall be utilized for
22 existing drainage projects and for providing for additional pumps for those projects and
23 excluding normal labor operating costs and other normal operational costs; such funds may
24 also be used to repair parish property damaged by storms.

25 (5) In the parishes of Acadia, Bienville, East Feliciana, Franklin, Jackson, St.
26 Helena, St. James, Vernon, Washington, and West Feliciana, fifty percent thereof to the
27 parish governing authority, twenty-five percent thereof to the parish school board except that
28 in the parish of Washington, which has a dual parish and city school administration, the
29 twenty-five percent to the school boards shall be prorated between the parish and city school
30 systems on the basis of public school population, and twenty-five percent thereof to the

1 incorporated municipalities in the parish, to be distributed to such incorporated
2 municipalities pro rata on a population basis, except that in the parish of West Feliciana the
3 initial fifteen thousand dollars of such excess shall be retained by the sheriff and the
4 twenty-five percent for incorporated municipalities shall be distributed to the town of St.
5 Francisville. In the parish of East Feliciana, the initial twenty-five thousand dollars of such
6 excess shall be retained by the sheriff.

7 (6) In the parish of Jefferson Davis, the portion of the excess equal to the ratio that
8 the public school population of the parish bears to the total population of the parish shall be
9 allocated and paid to the Jefferson Davis Parish School Board, ten thousand dollars shall be
10 allocated and paid to the Assessor for Jefferson Davis Parish, and of the remainder of the
11 excess, fifty percent thereof to the parish governing authority and fifty percent thereof to the
12 incorporated municipalities in the parish, two thousand one hundred dollars to be distributed
13 to each incorporated municipality and the balance thereof to be distributed to such
14 incorporated municipalities pro rata on a population basis.

15 (7) In the parish of St. Landry, thirty thousand dollars to the parish school board for
16 the operation of two food processing plants and the remainder as follows: twenty-five
17 percent to the sheriff for the operation and maintenance of his office; twenty-five percent to
18 the parish school board for use by the school board; twenty-five percent to the municipalities
19 of the parish, out of which five hundred dollars shall first be given to each municipality and
20 the balance shall be distributed to the municipalities on the basis of the formula applying to
21 the distribution of the tobacco tax; and twenty-five percent to the parish governing authority.

22 (8) In the parishes of Catahoula and Concordia, forty-four percent thereof to the
23 parish governing authority, thirty-three percent thereof to the parish school board, and
24 twenty-three percent thereof to the incorporated municipalities in the parish, to be distributed
25 to such incorporated municipalities pro rata on a population basis; prior to the distribution
26 of any excess funds in Concordia Parish, the parish libraries therein shall be reimbursed an
27 amount equal to any increase in the sheriff's commission deducted from library taxes over
28 and above the percentage authorized to be deducted in the 1975 calendar year; and the
29 balance of the excess shall be distributed as provided above in this Paragraph. However, in
30 the parish of Catahoula, the tax collector shall retain the sum of seventeen thousand dollars

1 of the excess, in addition to the commission provided in Section 6 of this Act, and the
2 balance of the excess shall be distributed as provided above in this Paragraph; and further,
3 in the parish of Concordia, the tax collector shall retain the sum of thirty-five thousand
4 dollars of the excess, in addition to the commission provided in Section 6 of this Act, and
5 the balance of the excess shall be distributed as provided above in this Paragraph.

6 (9) In the parishes of Sabine and Tangipahoa, forty percent thereof to the parish
7 governing authority, thirty percent thereof to the parish school board, and thirty percent
8 thereof to the incorporated municipalities in the parish, to be distributed to such incorporated
9 municipalities pro rata on a population basis.

10 (10) In the parishes of Tensas and Winn, thirty-five percent thereof to the parish
11 governing authority, thirty-five percent thereof to the parish school board, and thirty percent
12 thereof to the incorporated municipalities in the parish, to be distributed to such incorporated
13 municipalities pro rata on a population basis.

14 (11) In the parishes of Allen, Avoyelles, Bossier, Claiborne, DeSoto, East Carroll,
15 Evangeline, Iberia, Lafayette, Lincoln, Madison, Rapides, Richland, St. Martin, St. Mary,
16 Union, Webster, and West Carroll, thirty-three and one-third percent thereof to the parish
17 governing authority, thirty-three and one-third percent thereof to the parish school board, and
18 thirty-three and one-third percent thereof to the incorporated municipalities in the parish, to
19 be distributed to such incorporated municipalities pro rata on a population basis. Further,
20 in the parish of Evangeline the additional excess funds received by the school board as a
21 result of the change in percentages from those provided in Act 719 of the 1975 Regular
22 Session of the Louisiana Legislature shall be used solely for the purpose of restoring the
23 salaries or benefits to those school board employees to the same level or amount as were
24 paid prior to the recent reductions or decreases in such salaries or benefits; however, if the
25 excess funds are insufficient to restore the salaries or benefits to their former level or
26 amount, then the excess funds shall be distributed on a pro rata basis. In the parish of
27 Lafayette, the initial distribution shall be sixty thousand dollars to the Lafayette Association
28 for Retarded Citizens, Incorporated, for operating expenses, one hundred seventy thousand
29 dollars to the Lafayette Parish Sheriff, and the balance of the excess shall be distributed as
30 provided above in this Paragraph. In the parish of Union, the initial distribution shall be six

1 thousand dollars to the Spencer-West Sterlington Fire Protection District, Incorporated, for
2 operating expenses; thereafter, the sheriff and ex officio tax collector shall retain the sum of
3 fifty thousand dollars of the excess, in addition to the commission provided in Section 6 of
4 this Act, and the balance of the excess shall be distributed as provided above in this
5 Paragraph. In the parish of St. Mary, the parish governing authority shall make available out
6 of its allocated excess funds a sufficient amount to the parish registrar of voters to pay the
7 expenses of voter canvass required by law. In the parish of East Carroll the tax collector
8 shall retain the sum of fifteen thousand dollars of the excess, in addition to the commission
9 provided in Section 6 of this Act, and the balance of the excess shall be distributed as
10 provided above in this Paragraph. In the parish of Claiborne the tax collector may retain up
11 to an aggregate of ten percent of the excess as agreed to by resolution passed by the parish
12 governing authority before receiving its part designated in this Paragraph, by resolution
13 passed by the parish school board before receiving its part as designated in this Paragraph,
14 and a resolution from each municipality in said parish; each of the above bodies in Claiborne
15 Parish may provide the same or a different percentage for the sheriff but not to exceed ten
16 percent of its share. In the parish of Webster the tax collector may retain up to an aggregate
17 of ten percent of the excess to be received by the cities of Minden and Springhill and upon
18 passage of resolutions authorizing same by respective governing authorities may retain
19 amounts fixed in the resolution not to exceed ten percent of excess received by the police
20 jury of Webster Parish and each of the other incorporated municipalities in Webster Parish.

21 (12) In the parishes of Iberville, Pointe Coupee, and West Baton Rouge, thirty-three
22 and one-third percent thereof to the parish governing authority, thirty-three and one-third
23 percent thereof to the parish school board, and thirty-three and one-third percent thereof of
24 such excess amount to the incorporated municipalities in the parish, in the same amounts of
25 funds as were distributed to each in 1972 under the provisions of Act 4 of the 1972
26 Extraordinary Session except:

27 (a) If the amount of excess funds is insufficient to supply the amounts distributed
28 in 1972 to each incorporated municipality in the parish, the amount to be allocated and
29 distributed to each incorporated municipality shall be reduced by the ratio that the amount
30 of excess funds distributed to it in 1972 under Act 4 of the 1972 Extraordinary Session bore

1 to the total amount of excess funds then so distributed to all of the incorporated
2 municipalities in the parish; or

3 (b) If the amount of such excess funds exceeds the amount necessary to supply the
4 same amounts of excess funds distributed in 1972 to each incorporated municipality in the
5 parish, the excess over the amounts distributed in 1972 shall be allocated and distributed to
6 each incorporated municipality in the parish in the ratio that the population in each bears to
7 the total population of all of the incorporated municipalities in the parish.

8 However, in the parish of Pointe Coupee, the sheriff shall retain the sum of ten
9 thousand dollars of such excess amount, in addition to the commission provided in Section
10 6 of this Act, to be used for the operation and maintenance of his department, and the
11 balance of the excess shall be distributed as provided above in this Paragraph.

12 (13) In the parish of Ouachita, the funds shall be distributed as follows: thirty-three
13 percent thereof to the parish governing authority, thirty percent thereof to the city and parish
14 school boards to be prorated between the city and parish school boards on the basis of public
15 school population, and thirty-seven percent thereof to the incorporated municipalities in the
16 parish, to be distributed to such incorporated municipalities pro rata on a population basis.

17 (14) In the parish of Caddo, twenty-five percent thereof to the parish governing
18 authority, thirty-five percent thereof to the parish school board, and forty percent thereof to
19 the incorporated municipalities in the parish, to be distributed to such incorporated
20 municipalities pro rata on a population basis.

21 (15) In the parish of East Baton Rouge, such excess amount shall be distributed to
22 the East Baton Rouge Parish School Board, the East Baton Rouge City-Parish Government,
23 the town of Zachary, the city of Baker and the East Baton Rouge Parish Recreation
24 Commission in proportion to the ad valorem taxes collected by or reimbursed to each and
25 sales taxes collected by each in the twelve-month period ending June 30, 1974, and every
26 subsequent twelve-month period. However, twenty thousand dollars of such excess funds
27 shall be dedicated to each of the following volunteer fire departments: Pride, Sharon Hills,
28 Central, Brownsfield and East Side.

29 (16) In the parish of Calcasieu, thirty-three and one-third percent thereof to the
30 parish governing authority, thirty-three and one-third percent thereof to the parish school

1 board, and thirty-three and one-third percent thereof to the incorporated municipalities in the
2 parish, two thousand one hundred dollars to be distributed to each incorporated municipality
3 and the balance thereof to be distributed to such incorporated municipalities pro rata on a
4 population basis.

5 (17) In the parish of Beauregard, forty percent thereof to the parish governing
6 authority, thirty-five percent thereof to the parish school board, and twenty-five percent
7 thereof to the incorporated municipalities in the parish, to be distributed to such incorporated
8 municipalities pro rata on a population basis.

9 (18) In the parish of Morehouse, one-third thereof to the parish school board,
10 one-third thereof to the parish governing authority, and one-third thereof to the incorporated
11 municipalities in the parish, to be distributed to such incorporated municipalities pro rata on
12 a population basis.

13 (19) In the parish of Grant, fifty percent thereof to the sheriff and fifty percent
14 thereof to the parish governing authority.

15 (20) In the parish of Lafourche, one hundred percent thereof to the parish governing
16 authority, the first two hundred thousand dollars of which shall be used for existing parish
17 roads.

18 (21) In the parishes of Caldwell and LaSalle, one-third thereof to the parish
19 governing authority, one-third thereof to the parish school board, and one-third thereof to
20 the incorporated municipalities in the parish, to be distributed to such incorporated
21 municipalities pro rata on a population basis. Prior to the distribution of any excess funds
22 in LaSalle Parish, one thousand dollars shall be disbursed to the Hardtner Medical Center,
23 a publicly owned hospital, to be donated to the Medical Scholarship Fund, and five thousand
24 dollars shall be disbursed to the LaSalle Association for Developmentally Delayed, however,
25 none of these monies are to be used for salaries and provided that this amount is spent to
26 directly assist the students, and the balance of the excess shall be distributed as provided
27 above in this Paragraph.

28 (22) In the parish of Rapides, the initial fifteen thousand dollars of such excess shall
29 be paid over to the town of Ball, and the remainder of the excess shall be divided as follows:
30 thirty-three and one-third percent thereof to the parish governing authority, thirty-three and

1 one-third percent thereof to the parish school board, and thirty-three and one-third percent
2 thereof to the incorporated municipalities pro rata on a population basis.

3 (23) In the parish of Vermilion, sixty percent to the sheriff and forty percent to the
4 Vermilion Parish assessor.

5 (24) In the parish of Red River, the initial distribution shall be two thousand five
6 hundred dollars to the National Guard Armory located in said parish and the balance of the
7 excess shall be distributed as provided in Subsections A, B and C of this Section.

8 (25) In the parish of Assumption, the first twenty thousand dollars of excess shall
9 be distributed to the Assumption Parish Assessor, with the residual being distributed as
10 provided in Subsections A, B, and C of this Section.

11 E. In the parishes of Allen and Cameron, such excess amounts shall not be expended
12 until the parish or expending authority or agency has received the approval of a majority of
13 the legislative delegation representing the parish, the senators and representatives each
14 having an equal vote, provided that if there is a tie vote, the parish or expending authority
15 or agency shall have one vote in order to break the tie vote.

16 F. In order to provide flexibility in the use of excess funds, no excess funds shall be
17 distributed to any recipient by the tax collector of the parish of Evangeline as provided in
18 Section 10 of this Act until approval of such distribution of excess funds to each recipient
19 thereof has been granted by the member or members of the House of Representatives and
20 the Senate who represent the parish in the legislature. Such approval shall be requested by
21 the chief executive officer of the recipient body who shall submit to the respective members
22 of the legislature a written request for such excess funds, such written request to contain the
23 amount of excess funds requested and the purpose for which they will be expended. Upon
24 receipt, but only upon receipt, by the tax collector of the written approval of such a request
25 from each of the members of the legislature who represent the parish, the tax collector of the
26 parish shall make the distribution requested provided that such distribution is in compliance
27 with the provisions of this Act and particularly other provisions of Section 10 hereof.

28 Section 11. The parish governing authority shall have the power and authority to
29 expend such excess funds received by it for any governmental purpose or function and may

1 allocate and distribute any portion of such excess funds received by it to its tax recipient
2 bodies, sheriff, other taxing districts, incorporated municipalities, and other public officials.

3 Section 12. In accordance with the provisions of this Act, the amount to be
4 distributed to each parish and to the city of New Orleans during the Fiscal Year 2012-2013
5 shall be as follows:

12 Section 13. The state treasurer shall distribute one-third of the total amount herein
13 allocated to the parishes from the revenue sharing fund to the parish tax collector, or in
14 Orleans Parish to the city of New Orleans, not later than the first day of December in each
15 year, one-third thereof not later than the fifteenth day of March in each year and one-third
16 thereof not later than the fifteenth day of May in each year, and each one-third of the total
17 allocation shall be distributed in accordance with the provisions of Sections 6, 7, 9, and 10
18 of this Act; however, the legislative auditor may authorize the granting of additional sums
19 due any recipient in advance upon a showing that the advance receipt of such funds is
20 reasonably necessary. If the state treasurer does not distribute said fund on or before the
21 dates specified in this Act, any interest or other income derived by the state from the parish
22 allocations, earned prior to the distribution to the parishes, shall be paid over a pro rata basis
23 together with the principal amounts due the parishes under the provisions of this Act. Any
24 interest or other income derived by the parish tax collector or the city of New Orleans from
25 the investment or other use of such total parish allocations received from the state treasurer,
26 earned prior to the distributions within the parish as required by the foregoing provisions of
27 this Act, shall be paid over a pro rata basis together with the principal amounts due the local
28 recipients under the provisions of this Act upon distribution thereto, and the parish tax
29 collectors or the city of New Orleans may retain only investment income earned on that
30 portion of the total parish allocation to which they are otherwise entitled under the provisions

1 of this Act. In light of the fact that all assessment roll figures will not be available in time
2 to base the December distribution by the treasurer on current figures, the distribution of
3 funds on the first day of December pursuant to this Act shall be based on the distribution
4 figures for Fiscal Year 2010-2011. The remaining two distributions on the fifteenth day of
5 March and the fifteenth day of May shall be based on current figures for Fiscal Year 2011-
6 2012, and such distributions shall be adjusted to compensate for the differences resulting in
7 the use of the Fiscal Year 2010-2011 figures for the December distribution.

8 Section 14. On or before such date as shall be established by the state treasurer, each
9 tax collector, the city of New Orleans, and the city treasurer of the city of Monroe annually
10 shall file with the state treasurer, on such forms as the state treasurer may require, all
11 information necessary to the computation of the funds to be distributed within the parishes,
12 including, but not limited to, a listing of all such local entities seeking eligibility for funds
13 as a tax recipient body under the qualifications set out in Section 1(a), all new millages of
14 such tax recipient bodies as are listed in Section 9(B), and all remaining authorities on the
15 tax rolls which are otherwise ineligible to participate in the distribution of revenue sharing
16 funds as tax recipient bodies. The listing shall include such verification for eligibility as
17 may be required by the state treasurer and, notwithstanding the provisions of Section 12
18 hereof, no revenue sharing funds shall be distributed prior to receipt and acceptance by the
19 state treasurer of such information and verification. The same authorities shall in the same
20 manner submit to the state treasurer a statement of the amount of revenue sharing funds
21 distributed to each recipient of such funds, including the amount deducted for sheriffs'
22 commissions and for retirement system contributions and shall state clearly on such forms
23 the amount of the distribution to each such recipient which is derived from excess funds and
24 the amount of such distribution which represents reimbursement for tax losses by reasons
25 of the homestead exemption. Such statement shall also include the amount of any revenue

HB No. 1091

Abstract: Provides relative to the Revenue Sharing Fund.

Paragraphs (1) through (7) of this digest contain no changes from FY 2011-2012 and only restate the general provisions of last year's distribution; all changes for FY 2012-2013 are contained in Paragraphs (8) and (9) of this digest.

- (1) Provides for the annual allocation and distribution of the state revenue sharing fund in the amount of \$90,000,000 for FY 2012-2013. The parish allocation is determined by the parish's percentage of the total state population (80% of the revenue sharing fund) and the parish's percentage of the total number of homesteads in the state (20% of the revenue sharing fund).
- (2) Requires the state treasurer to remit the total parish allocation in three allotments no later than Dec. 1, March 15, and May 15, and further requires the sheriff to distribute such funds to the tax recipient bodies within 15 days after receipt. Authorizes the sheriff to distribute the first payment based on the previous year pending receipt of the current tax rolls and requires adjustments on the final two payments.
- (3) The constitution mandates payment, on a first priority basis from the parish allocation, of the sheriff's commission, retirement systems' deductions, and reimbursement to eligible tax recipient bodies for ad valorem taxes lost as a result of the homestead exemption; any monies remaining in the parish allocation after such payments are made are referred to as "excess funds" and are distributed on the basis of a local formula contained in the Act.
- (4) Provides that in any parish which had excess funds in 1977, except East Carroll, the amount available for the reimbursement of homestead exemption losses shall be limited to the amount used for that purpose in 1977, adjusted by the percentage by which the number of homesteads in the parish increased from 1977 to 2011. Prohibits participation of new millages levied after Jan. 1, 1978, unless authorized to participate on the same pro rata basis by the local legislative delegation.
- (5) Prohibits general obligation bond millages from participating in revenue sharing and restates the constitutional mandate that the issuing authority levy sufficient millage on all taxable property to pay annual debt requirements. Excepts Sabine Parish with operation and maintenance millages having first priority over bond millages, excepts Natchitoches Parish with maintenance and bond millages sharing pro rata, excepts the BREC Capital Improvement Tax in East Baton Rouge Parish, and excepts all bonds in Bossier Parish.
- (6) Requires that all local distribution authorities file with the state treasurer all information necessary for the computation and verification of amounts due the eligible taxing bodies, and provides that no funds shall be distributed prior to receipt of such information. Directs the state treasurer and sheriff to pay to a recipient any earnings received from the investments of the parish allocation.

- (7) Retains all prior authorized participations from Act No. 1037 of the 2010 R.S.
- (8) The population determination shall be the most recent release by the U.S. Census Bureau prior to the current fiscal year.
