1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" and before "Part" insert "R.S. 36:802(introductory  
3 paragraph),"

4 AMENDMENT NO. 2

5 On page 1, line 4, after "1300.11," and before "relative" insert "and to enact R.S.  
6 36:259(MM),"

7 AMENDMENT NO. 3

8 On page 1, line 10, after "regulations;" and before "to" insert "to provide for placement of  
9 the Louisiana Medical Disclosure Panel within the Department of Health and Hospitals;"

10 AMENDMENT NO. 4

11 On page 1, between lines 12 and 13, insert the following:

12 "Section 1. R.S. 36:802(introductory paragraph) is hereby amended and  
13 reenacted and R.S. 36:259(MM) is hereby enacted to read as follows:  
14 §259. Transfer of agencies and functions to Department of Health and  
15 Hospitals

17 MM. The Louisiana Medical Disclosure Panel (R.S. 40:1299.39.6) is  
18 placed within the Department of Health and Hospitals and shall exercise and  
19 perform its powers, duties, functions, and responsibilities in the manner  
20 provided for agencies transferred in accordance with the provisions of R.S.  
21 36:802.

23 §802. Transfer; retention of policymaking and rulemaking functions  
24 The agencies transferred by the provisions of R.S. 36:209(Q), 239(E),  
25 259(B), 259(T), ~~259(MM)~~, 309(B), 359(B), 409(C), 459(B), 509(B), 610(B),  
26 629(I), and 769(C) shall continue to be composed and selected as provided  
27 by law, and each shall continue to exercise all of the powers, duties,  
28 functions, and responsibilities provided or authorized for each by the  
29 constitution or laws which are in the nature of policymaking, rulemaking,  
30 licensing, regulations, enforcement, or adjudication and also shall continue  
31 to exercise all advisory powers, duties, functions, and responsibilities  
32 provided by law. Such powers, duties, functions, and responsibilities shall  
33 be exercised independently of the secretary and any assistant secretary,  
34 except that:
