(2) An individual applying for the first renewal of registration of a motor vehicle, trailer, semitrailer, or other vehicle intended to be operated upon the public highways of this state shall provide on the application his full legal name and license number as it appears on his official driver's license or identification card a current and valid photo identification which includes the owner's full legal name and license number or identification card number issued in this state, another state, or by the United States military. An individual applying for a first renewal through the mail shall include a copy of a current and valid photo identification which includes the owner's full legal name and license number or identification card number issued in this state, another state, or by the United States military with his application. The individual's full legal name and the number on the identification provided shall be placed on the application.

St. Germain HB No. 1112

Abstract: Requires submission of a current and legal photo identification with the motor vehicle registration application.

<u>Present law</u> requires every owner of a motor vehicle to register that vehicle with the office of motor vehicles and pay the motor vehicle registration tax. Requires submission of the owner's full legal name and license number from the driver's license or state identification card on the application.

Proposed law retains present law.

<u>Proposed law</u> would require submission of a current and valid photo identification which would include the owner's full legal name and license number.

<u>Proposed law</u> would require a copy of a current and valid photo identification which would include the owner's full legal name and license number with applications that are mailed.
