8 On page 2, line 10, change "indemnities" to "**indemnitee**"

9 AMENDMENT NO. 4

10 On page 2, line 11, change "**indemnities**" to "**indemnitee's**"

11 AMENDMENT NO. 5

12 On page 2, line 17, change "indemnities" to "**indemnitee**"

13 AMENDMENT NO. 6

14 On page 2, line 19, change both occurrences of the word "indemnities" to "**indemnitee**"

2 On page 3, line 16, change "**property damage**" to "**damage to the indemnitor's personnel**
3 **or property**"

4 AMENDMENT NO. 14

5 On page 3, at the end of line 17, insert the following:

6 **"The provisions of this Paragraph shall not apply to the intentional acts**
7 **of any party, or any party's contractors, employees, and invitees."**

8 AMENDMENT NO. 15

9 On page 3, line 19, change "**indemnities**" to "**indemnitee**"

10 AMENDMENT NO. 16

11 On page 3, line 20, change "**indemnities**" to "**indemnitee**"

12 AMENDMENT NO. 17

13 On page 3, line 23, after "**price**" insert "**; provided, however, that the indemnitor's**
14 **liability under such clause shall be limited to the amount of the proceeds that were**
15 **payable under the insurance policy or policies that the indemnitor was required to**
16 **obtain**"

18 On page 3, line 25, change "**indemnities**" to "**indemnitee**"

20 On page 3, line 29, after "**Subsection**" insert "**; provided that such insurance coverage is**
21 **only provided where the indemnitor is at least partially at fault or otherwise liable for**
22 **damages ex delicto or quasi ex delicto**"
