## HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Abramson to Engrossed House Bill No. 477 by Representative Abramson

1 AMENDMENT NO. 1

2 On page 1, line 11, after "than" and before "days" change "one hundred eighty" to "ninety"  
3 and at the end of the line, delete "a" and insert ":

4 AMENDMENT NO. 2

5 On page 1, delete lines 12 through 17 in their entirety and insert the following:

6 "(1) A statement of all existing or potential claims against any trust  
7 created pursuant to Title 11 of the United States Code; or

8 (2) A statement that no claims will be filed by that plaintiff or person  
9 whose exposure is alleged to be the cause of the claim, against any trust  
10 created pursuant to Title 11 of the United States Code, for the purpose of  
11 processing, liquidating, paying, or satisfying asbestos or silica claims.

12 B. A statement made pursuant to Paragraph A of this Article shall be  
13 a sworn statement, under oath, by a plaintiff attesting that the plaintiff and  
14 counsel have conducted a good faith investigation of all existing or potential  
15 trust claims."

16 AMENDMENT NO. 3

17 On page 1, at the beginning of line 18, change "conducted. The statement" to "A statement  
18 made pursuant to Subparagraph (A)(1)"

19 AMENDMENT NO. 4

20 On page 1, line 20, after "a" and before the period, change "fund" to "trust"

21 AMENDMENT NO. 5

22 On page 2, line 1, after "supplement" and before "within" change "the sworn statement" to  
23 "a sworn statement made pursuant to Paragraph A"

24 AMENDMENT NO. 6

25 On page 2, line 2, after "trust claims" delete the remainder of the line and insert a period

26 AMENDMENT NO. 7

27 On page 2, delete line 3 in its entirety and insert the following:

28 "A statement made pursuant to Subparagraph (A)(2) may be withdrawn prior  
29 to trial if a statement made pursuant to Subparagraph (A)(1) is filed as a  
30 substitute for the statement made pursuant to Subparagraph (A)(2). In the  
31 event a statement is filed as a substitute within ninety days of a trial date set

1 in a matter, the trial shall be continued no less than ninety days from the date  
2 the substitute statement is filed or the documents set forth in Paragraph B are  
3 produced, whichever is later."

4 AMENDMENT NO. 8

5 On page 2, at the beginning of line 4, change "B" to "C"

6 AMENDMENT NO. 9

7 On page 2, at the beginning of line 9, change "C" to "D"

8 AMENDMENT NO. 10

9 On page 2, at the beginning of line 12, change "D" to "E"

10 AMENDMENT NO. 11

11 On page 2, at the beginning of line 16, change "E" to "F"
