PUBLIC CONTRACT/BIDS: Revises public bid provisions to include certain exceptions for certain letting authorities

1	AN ACT
2	To amend and reenact R.S. 38:2212(A)(1)(b)(ii)(bb) and (3)(c)(ii), relative to public bids;
3	requires lowest bidders on certain contracts to submit certain documentation and
4	information within a certain time; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 38:2212(A)(1)(b)(ii)(bb) and (3)(c)(ii) are hereby amended and
7	reenacted to read as follows:
8	§2212. Advertisement and letting to lowest responsible bidder; public work;
9	electronic bidding; participation in mentor-protégé program; exemptions

16	(bb) Other documentation and information required shall be furnished by the
17	low bidder within ten days after the bid opening. The ten-day period shall not be
18	altered or waived by any public entity except the city of Baton Rouge, East Baton
19	Rouge Parish, the Airport Authority of Airport District No. 1 of Calcasieu Parish, the
20	city of Shreveport, the Shreveport Airport Authority, the Lafayette Airport

11	(ii) The bid form shall contain Bid Security or Bid Bond, Acknowledgment
12	of Addenda, Base Bid, Alternates, Signature of Bidder, Name, Title, and Address of
13	Bidder, Name of Firm or Joint Venture Corporate Resolution, and Louisiana
14	Contractors License Number, and on public works projects where unit prices are
15	utilized, their inclusion in the bid form; however, unit prices shall not be utilized for
16	the construction of building projects, unless the unit price is incorporated into the
17	base bid. Other documentation required shall be furnished by the low bidder within
18	ten days after the bid opening. The city of Baton Rouge, East Baton Rouge Parish,
19	the Airport Authority of Airport District No. 1 of Calcasieu Parish, the city of
20	Shreveport, the Shreveport Airport Authority, the Sewerage and Water Board of New
21	Orleans, and all agencies of the City of New Orleans, including but not limited to the
22	Regional Transit Authority and the New Orleans Aviation Board shall require that
23	the other documentation referred to above shall be furnished by the two lowest
24	bidders within three days of the bid opening. The division of administration, office
25	of facility planning and control, shall develop and prescribe the necessary bid form
26	for public works projects for public bid purposes and implement the provisions of
27	this Section of the bid form in accordance with the Administrative Procedure Act.

Abstract: Requires the two lowest bidders on projects let by the city of Baton Rouge, East Baton Rouge Parish, the Airport Authority of Airport District No. 1 of Calcasieu Parish, Lafayette Airport Commission, the city of Shreveport, and the Shreveport Airport Authority to submit certain documentation and information within three days of the bid opening.

<u>Present law</u> provides that required documentation and information, other than the bid form and accompanying documents, shall be submitted by the low bidder within 10 days after the bid opening.

<u>Present law</u> provides that such documentation and information for projects let by the Sewerage and Water Board of New Orleans, and all agencies of the City of New Orleans, including but not limited to the Regional Transit Authority and the New Orleans Aviation Board shall be furnished by the two lowest bidders within three days of the bid opening.

<u>Proposed law</u> adds the city of Baton Rouge, East Baton Rouge Parish, the Airport Authority of Airport District No. 1 of Calcasieu Parish, Lafayette Airport Commission, the city of Shreveport, and the Shreveport Airport Authority.
