18 **"D.(1) The announcement required in Paragraph A(1) of this Section**
19 **shall be published, without cost to the parish or municipality, in the official**
20 **journal of the parish or municipality where the property is located on two**
21 **separate days within sixty days of receipt of the notice and written report by the**
22 **state fire marshal. Failure to publish such announcement shall subject the**
23 **owner to a fifty dollar per day penalty, not to exceed five thousand dollars per**
24 **property.**
25 **(2) Any penalties collected shall be remitted by the parish or**
26 **municipality to the Louisiana Blighted Property Reclamation Revolving Loan**
27 **Fund as provided for in R.S. 33:4770."**
