## HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Tim Burns to Engrossed House Bill No. 1 by Representative Fannin

1    AMENDMENT NO. 1

2    On page 12, between lines 14 and 15, insert the following:

3                    "F. The commissioner of administration is hereby authorized and directed to  
4    reduce the State General Fund (Direct) appropriations and other means of financing  
5    appropriations contained in each department and budget unit contained in this Act  
6    and the Ancillary Appropriations Act to achieve a State General Fund (Direct)  
7    savings of at least \$32,087,856 from the furlough of employees for 4 calendar days  
8    during Fiscal Year 2012-2013. Each department and budget unit contained in this  
9    Act and the Ancillary Appropriations Act shall submit a furlough plan to the  
10   commissioner of administration for review and approval. Such furlough plans shall  
11   stagger employee furloughs to have the least impact on services."

12   AMENDMENT NO. 2

13   On page 12, between lines 14 and 15, insert the following:

14                   "G. The commissioner of administration is hereby authorized and directed to  
15   adjust the means of financing contained in this Act and the Ancillary Appropriations  
16   Act by reducing the appropriation out of the State General Fund (Direct) by  
17   \$44,241,500. Provided further, however, that the commissioner of administration  
18   is authorized and directed to make such adjustments to program expenditures for  
19   salaries and related benefits for vacant authorized positions to achieve such savings."

20   AMENDMENT NO. 3

21   On page 12, between lines 14 and 15, insert the following:

22                   "H. The commissioner of administration is hereby authorized and directed to  
23   reduce the State General Fund (Direct) appropriations contained in each department  
24   and budget unit contained in this Act by 5% of the discretionary State General Fund  
25   (Direct) funding proposed in the Executive Budget for such department and budget  
26   unit, to achieve a savings of State General Fund (Direct) of not less than  
27   \$120,843,004."

28   AMENDMENT NO. 4

29   On page 12, between lines 16 and 17, insert the following:

30                   "I. The commissioner of administration is hereby authorized and directed to  
31   reduce the State General Fund (Direct) appropriations and other means of financing  
32   appropriations contained in each department and budget unit contained in this Act  
33   and the Ancillary Appropriations Act to achieve a State General Fund (Direct)  
34   savings of at least \$15,000,000 from a reduction in the total dollar value of  
35   contracts."

1 AMENDMENT NO. 5

3 "J. The legislature hereby recognizes its intention, as represented by its  
4 presiding officers, to reduce its expenditures out of the State General Fund (Direct)  
5 during Fiscal Year 2012-2013 by \$6,926,393."
