
SENATE FLOOR AMENDMENTS

Amendments proposed by Senators Ward and Amedee to Reengrossed Senate Bill No. 52

1 AMENDMENT NO. 1

2 On page 2, line 6 after "**(aa)**" delete the remainder of the line and delete lines 7 through 10
3 and insert

4 "Until the later of June 30, 2014, or the date in (bb) - 11.5%.

5 (bb) Beginning the July first following the employee's first merit increase of a
6 minimum of four percent awarded on or after July 2, 2013, the employee's contribution
7 rate shall increase by 0.5% each fiscal year for four consecutive years."

8 AMENDMENT NO. 2

9 On page 2, line 14 after "**(aa)**" delete the remainder of the line and delete lines 15 through
10 18 in their entirety and insert:

11 "Until the later of June 30, 2014, or the date in (bb) - 8%.

12 (bb) Beginning the July first following the employee's first merit increase of a
13 minimum of four percent awarded on or after July 2, 2013, the employee's contribution
14 rate shall increase by 0.5% each fiscal year for four consecutive years."

15 AMENDMENT NO. 3

16 On page 2, line 27 after "**(aa)**" delete the remainder of the line and delete lines 28 through
17 29 and on page 3 delete lines 1 and 2 in their entirety and insert:

18 "Until the later of June 30, 2014, or the date in (bb) - 9.5%.

19 (bb) Beginning the July first following the employee's first merit increase of a
20 minimum of four percent awarded on or after July 2, 2013, the employee's contribution
21 rate shall increase by 0.5% each fiscal year for four consecutive years."

22 AMENDMENT NO. 4

23 On page 3, line 5 after "**(aa)**" delete the remainder of the line and delete lines 6 through 9
24 in their entirety and insert:

25 "Until the later of June 30, 2014, or the date in (bb) - 8%.

26 (bb) Beginning the July first following the employee's first merit increase of a
27 minimum of four percent awarded on or after July 2, 2013, the employee's
28 contribution rate shall increase by 0.5% each fiscal year for four consecutive years."

29 AMENDMENT NO. 5

30 On page 3, line 15 after "**(aa)**" delete the remainder of the line and delete lines 16 through
31 19 in their entirety and insert:

32 "Until the later of June 30, 2014, or the date in (bb) - 7.5%.

33 (bb) Beginning the July first following the employee's first merit increase of a
34 minimum of four percent awarded on or after July 2, 2013, the employee's contribution
35 rate shall increase by 0.5% each fiscal year for four consecutive years."

1 AMENDMENT NO. 6

2 On page 3, line 22 after "(aa)" delete the remainder of the line and delete lines 23 through
3 26 in their entirety and insert:

4 "Until the later of June 30, 2014, or the date in (bb) - 8%.

5 (bb) Beginning the July first following the employee's first merit increase of a
6 minimum of four percent awarded on or after July 2, 2013, the employee's contribution
7 rate shall increase by 0.5% each fiscal year for four consecutive years."

8 AMENDMENT NO. 7

9 On page 4, line 5 after "(i)" delete the remainder of the line and delete lines 6 through 9 in
10 their entirety and insert:

11 "Until the later of June 30, 2014, or the date in (ii) - 8%.

12 (ii) Beginning the July first following the employee's first merit increase of a
13 minimum of four percent awarded on or after July 2, 2013, the employee's contribution
14 rate shall increase by 0.5% each fiscal year for four consecutive years."
