Provides for access to employee records

Proposed law directs the LA Workforce Commission (LWC) to provide an employee with wage and employment records upon written request by employee or his representative. The records may be transferred electronically according to the Fair Credit Reporting Act on an individual basis at the expense of the requester. The records will not be maintained or reported with other Fair Credit Reporting Act regulated data. The LWC may promulgate rules to carry out the provisions of this bill, including security of the data.
