1 AMENDMENT NO. 1

2 On page 1, line 13, after "who has passed" delete the remainder of the line and insert "the"

3 AMENDMENT NO. 2

4 On page 1, line 14, after "R.S. 35:191.1," insert "except for any performance assessment  
5 component,"

6 AMENDMENT NO. 3

7 On page 2, line 6, after "(2)" insert "(a)"

8 AMENDMENT NO. 4

9 On page 2, line 11, after "Subsection shall" insert "only include businesses that are in  
10 existence on the effective date of this Act, but shall"

11 AMENDMENT NO. 5

12 On page 2, line 15, change "(a)" to "(i)"

13 AMENDMENT NO. 6

14 On page 2, line 18, change "(b)" to "(ii)"

15 AMENDMENT NO. 7

16 On page 2, between lines 20 and 21 insert the following:

17 "(b) A notary commissioned pursuant to this Subsection shall not do any of the  
18 following in the course and scope of his employment;

19 (i) Draft and prepare a last will and testament or donation mortis causa.

20 (ii) Draft and prepare a trust.

21 (iii) Draft and prepare any instrument that transfers title to immovable property  
22 including, but not limited to, an act of sale or act of donation."

24 On page 3, at the end of line 13 and before the period "." insert the following:

25 "and the penalties that may be imposed for violations of the limitations and  
26 prohibitions imposed by this Subsection"

28 On page 4, line 6, after "performance assessment" delete "or other"

2 On page 4, line 8, after "performance assessment" delete "or other"

3 AMENDMENT NO. 11

4 On page 4, line 10, after "assessment" delete "or other"

5 AMENDMENT NO. 12

6 On page 4, line 14, after "act exceeded the" delete the remainder of the line, delete lines 15  
7 and 16 in their entirety, and insert:

8 "authority or jurisdiction limitations imposed by Paragraphs (2) and (3) of this  
9 Subsection."

10 AMENDMENT NO. 13

11 On page 4, delete lines 22 through 29 in their entirety, on page 5 delete line 1, and insert the  
12 following:

13 "(7) Any person receiving a notary commission pursuant to this Subsection may have  
14 his commission suspended by the secretary of state if the secretary of state receives  
15 a sworn complaint that the notary exceeded his authority or jurisdiction provided by  
16 this Subsection. During the period of suspension, the notary shall have no authority  
17 to exercise any of the duties or functions of a notary public. The secretary of state  
18 shall notify the notary by certified mail, return receipt requested, of the suspension  
19 and that the notary has thirty days from receipt of the notice to file a written appeal  
20 with the secretary of state contesting the decision to suspend the notarial  
21 commission. If the notary fails to file a written appeal within thirty days of receipt  
22 of the notice or the secretary of state determines that the suspension should be upheld  
23 after receipt of a written appeal, the secretary of state shall notify the district attorney  
24 of the parish in which the notary is commissioned for the purpose of institution of  
25 a rule to show cause to revoke the commission pursuant to R.S. 35:15."
