- 23 On page 16, between lines 21 and 22, insert:
- 24 "§7017.1. Algiers-Canal Street Ferry Fund; ferry operations
- A. There is hereby created, as a special fund in the state treasury, the 25 26 Algiers-Canal Street Ferry Fund, hereinafter referred to as the "fund". 27 Notwithstanding any provision of law to the contrary, beginning January 1, 28 2013, and each fiscal year thereafter, after compliance with the requirements 29 of Article VII, Section 9(B) of the Constitution of Louisiana, and after 30 making the allocation for state highway fund No. 2, the treasurer shall deposit into the fund, all of the funds derived from the collection of 31 32 registration and license fees and taxes collected by the state pursuant to R.S.
- 47:462, and as provided in R.S. 47:481, in the parish of Orleans.
- B. The monies in the fund shall be subject to an annual appropriation
  by the legislature and shall only be used as provided in Subsection C of this
  Section. The monies in the fund shall be invested by the treasurer in the
  same manner as the monies in the state general fund, and all interest earned
  shall be deposited and credited to the fund. All unexpended or
  unencumbered monies remaining in the fund at the end of the fiscal year
- shall remain to the credit of the fund.
- 41 <u>C. Monies appropriated from the fund shall be used exclusively by</u>
  42 <u>the Department of Transportation and Development to fund operations of the</u>
- 43 <u>Algiers-Canal Street ferry."</u>
