1 AMENDMENT NO. 1

4 and before "and" insert "or any variation thereof for the most recent year."

13 AMENDMENT NO. 4

14 In Senate Committee Amendment No. 5, proposed by the Senate Committee on Revenue and
15 Fiscal Affairs, and adopted by the Senate on May 15, 2012 on page 1, line 14, after "insert
16 "" and before "and" insert "for the most recent year."

17 AMENDMENT NO. 5

18 On page 2, between lines 27 and 28, insert the following:

19 "(5)(a) The governing authority of the public school which has received a
20 donation eligible for a rebate pursuant to this Section shall provide a public report
21 to the Department of Revenue which shall be prepared by a certified public
22 accountant and shall be submitted to the department no later than the first day of
23 January each year. The report shall contain the name and address of the public
24 school, the total number and total dollar amount of donations received during the
25 previous fiscal year, the total amount of contributions made by each contributor
26 during the previous calendar year, and the social security number or Louisiana
27 taxpayer identification number of each contributor.

28 (b) Upon receipt of such report, the Department of Revenue shall prepare
29 from its records as an addendum to each report, the amount and date of issuance of
30 each rebate issued for a donation made to such school pursuant to this Section. The
31 release of such information shall not be a violation of R.S. 47:1508.

32 (c) An electronic format for this report shall be furnished to the Department
33 of Education by the Department of Revenue on or by the first day of February of
34 each year."

36 On page 3, line 1, delete "ten" and, on line 2, delete "million dollar" and insert "current year"

37 AMENDMENT NO. 7

38 On page 3, line 5, after "been issued" insert "starting on January first for income tax years
39 ending prior to that date"
