HOUSE BILL NO. 1082

1 AN ACT

2 To amend and reenact R.S. 26:71.1(1)(h) and 271.2(1)(h) and to enact R.S. 26:73(C)(6) and
3 272(C)(6), relative to permits issued by the commissioner of alcohol and tobacco
4 control; to provide for Class A-General retail permits for low and high alcoholic
5 beverages; to require a Class A-General retail establishment to adhere to certain
6 guidelines relative to public restrooms; to require the retail establishment to obtain
7 proof of compliance from the office of public health; to prohibit the issuance of
8 certain permits to establishments engaged in certain live entertainment; and to
9 provide for related matters.

10 Be it enacted by the Legislature of Louisiana:

11 Section 1. R.S. 26:71.1(1)(h) and 271.2(1)(h) are hereby amended and reenacted and
12 R.S. 26:73(C)(6) and 272(C)(6) are hereby enacted to read as follows:
