1 AMENDMENT NO. 1

2 Delete Senate Committee Amendments Nos. 1, 2 and 3 proposed by the Senate Committee  
3 on Commerce, Consumer Protection and International Affairs (set SCAHB1015  
4 DUCHARMM 4483) and adopted by the Senate on May 17, 2012

5 AMENDMENT NO. 2

6 On page 1, line 2, after "R.S. 32:1253(A)(1)(introductory paragraph)" and before the comma  
7 "," insert "and (2) and (H)"

8 AMENDMENT NO. 3

9 On page 1, line 3, after "membership;" insert "to provide for an appeal of a decision of the  
10 commission; to provide for venue;"

11 AMENDMENT NO. 4

12 On page 1, line 6, change "is hereby" to "and (2) and (H) are hereby"

13 AMENDMENT NO. 5

14 On page 1, after line 17, insert the following:

15 "(2) Each of the commissioners appointed under the provisions of  
16 Paragraph (1) of this Subsection shall have been an actively engaged  
17 licensee of the commission or its previous Louisiana licensing  
18 commission for not less than five consecutive years prior to such  
19 appointment, and be a holder of such a license at all times while a  
20 member of the commission. Being engaged in more than one such  
21 pursuit shall not disqualify a person otherwise qualified from serving  
22 on the commission. Of these members, one member shall be  
23 primarily engaged in the business of lease or rental, one member  
24 shall be primarily engaged in the business of heavy truck sales, ~~three~~  
25 ~~members shall be primarily engaged in the business of recreational~~  
26 ~~products; one member shall be primarily engaged in the business of~~  
27 ~~marine product sales, one member shall be primarily engaged in the~~  
28 ~~business of motorcycle sales, one member shall be primarily engaged~~  
29 ~~in the business of recreational vehicle sales, and one member shall be~~  
30 primarily engaged in the business of sales finance.

31 \* \* \*

32 H.(1) The commission shall, in addition to the powers herein  
33 conferred, be constituted a body politic or political corporation,  
34 invested with the powers inherent in corporations, including but not  
35 limited to the power and authority to own immovable property. It  
36 may sue and be sued under the style of the commission, and all  
37 process against the commission shall be served on the chairman or  
38 executive director in person, and all suits on behalf of the  
39 commission shall be brought by the chairman. The domicile for the  
40 purpose of being sued shall be Jefferson Parish. No member of the  
41 commission, or the executive director, shall be subject to suit or be  
42 held liable as an individual in any suit against the commission.

43 (2) An appeal of any decision of the commission shall be brought in  
44 the Nineteenth Judicial District Court."
