2	To amend and reenact R.S. 38:2212(A)(1)(b)(ii)(bb) and (3)(c)(ii), relative to public bids;
3	requires lowest bidders on certain contracts to submit certain documentation and
4	information within a certain time; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 38:2212(A)(1)(b)(ii)(bb) and (3)(c)(ii) are hereby amended and
7	reenacted to read as follows:
8	§2212. Advertisement and letting to lowest responsible bidder; public work;
9	electronic bidding; participation in mentor-protégé program; exemptions
10	A.(1)

16	(bb) Other documentation and information required <u>including but not limited</u>
17	to the low bidder's attestation pursuant to R.S. 38:2212.10 and 2227 shall be
18	furnished by the low bidder within ten days after the bid opening. The ten-day
19	period shall not be altered or waived by any public entity except the governing
20	authority of any publicly owned commercial aviation airport, the Sewerage and
21	Water Board of New Orleans, and all agencies of the City of New Orleans, including
22	but not limited to the Regional Transit Authority and the New Orleans Aviation
23	Board, who shall require that the other documentation and information referred to
24	above in this Subitem be furnished by the two lowest bidders within three days of
25	after the bid opening.

HB NO. 1129 **ENROLLED** 1 (3) 2 3 (c) 4 5 (ii) The bid form shall contain Bid Security or Bid Bond, Acknowledgment 6 of Addenda, Base Bid, Alternates, Signature of Bidder, Name, Title, and Address of 7 Bidder, Name of Firm or Joint Venture Corporate Resolution, and Louisiana 8 Contractors License Number, and on public works projects where unit prices are 9 utilized, their inclusion in the bid form; however, unit prices shall not be utilized for 10 the construction of building projects, unless the unit price is incorporated into the 11 base bid. Other documentation required shall be furnished by the low bidder within 12 ten days after the bid opening. The governing authority of any publicly owned 13 commercial aviation airport, the Sewerage and Water Board of New Orleans, and all 14 agencies of the City of New Orleans, including but not limited to the Regional 15 Transit Authority and the New Orleans Aviation Board shall require that the other 16 documentation referred to above shall be furnished by the two lowest bidders within 17 three days of after the bid opening.
