# ACT No. 435

1 AN ACT

2 To amend and reenact Section 3 of Act No. 535 of the 1988 Regular Session of the  
3 Legislature, as amended by Section 2 of Act No. 285 of the 1992 Regular Session  
4 of the Legislature, Section 3 of Act No. 1291 of the 1997 Regular Session of the  
5 Legislature, Section 1 of Act No. 50 of the 1998 Regular Session of the Legislature,  
6 Section 1 of Act No. 7 of the 2001 First Extraordinary Session of the Legislature,  
7 Section 1 of Act No. 14 of the 2004 First Extraordinary Session of the Legislature,  
8 Section 1 of Act No. 76 of the 2006 Regular Session of the Legislature, and Section  
9 1 of Act No. 232 of the 2008 Regular Session of the Legislature, relative to the  
10 Louisiana Tax Free Shopping Program; to change the termination date of the  
11 program; and to provide for related matters.

12 Be it enacted by the Legislature of Louisiana:

13 Section 1. Section 3 of Act No. 535 of the 1988 Regular Session of the Legislature,  
14 as amended by Section 2 of Act No. 285 of the 1992 Regular Session of the Legislature,  
15 Section 3 of Act No. 1291 of the 1997 Regular Session of the Legislature, Section 1 of Act  
16 No. 50 of the 1998 Regular Session of the Legislature, Section 1 of Act No. 7 of the 2001  
17 First Extraordinary Session of the Legislature, Section 1 of Act No. 14 of the 2004 First  
18 Extraordinary Session of the Legislature, Section 1 of Act No. 76 of the 2006 Regular  
19 Session of the Legislature, and Section 1 of Act No. 232 of the 2008 Regular Session of the  
20 Legislature are hereby amended and reenacted to read as follows:

21 Section 3. This Act shall become effective upon signature by the governor  
22 or, if not signed by the governor, upon expiration of the time for bills to become law

1 without signature by the governor, as provided in Article III, Section 18 of the  
2 Constitution of Louisiana and shall be effective through July 1, ~~2013~~ 2017.

3 Section 2. This Act shall become effective on July 1, 2012; if vetoed by the governor  
4 and subsequently approved by the legislature, this Act shall become effective on July 1,  
5 2012, or on the day following such approval by the legislature, whichever is later.
