APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgments in the matter of "Claudia Salley v. State of Louisiana, DOTD, et al" c/w "Jamey L. Salley v. State of Louisiana, DOTD, et al" c/w "Charles Grippando and Wyna L. Grippando v. State of Louisiana, DOTD, et al"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2013-  
3 2014 to be used to pay the consent judgments in the suit entitled "Claudia Salley v.  
4 State of Louisiana, Department of Transportation and Development" consolidated  
5 with "Jamey L. Salley v. State of Louisiana, Department of Transportation and  
6 Development" consolidated with "Charles Grippando and Wyna L. Grippando v.  
7 State of Louisiana, Department of Transportation and Development, et al"; and to  
8 provide for related matters.

9 Be it enacted by the Legislature of Louisiana:

10 Section 1. The sum of Three Hundred Five Thousand Four Hundred Ten and No/100  
11 (\$305,410.00) Dollars in favor of plaintiff, Claudia Salley, is hereby appropriated out of the  
12 General Fund of the state of Louisiana for Fiscal Year 2013-2014 to be used to pay the  
13 consent judgment in the suit entitled "Claudia Salley v. State of Louisiana, Department of  
14 Transportation and Development" consolidated with "Jamey L. Salley v. State of Louisiana,  
15 Department of Transportation and Development" consolidated with "Charles Grippando and  
16 Wyna L. Grippando v. State of Louisiana, Department of Transportation and Development,  
17 et al", bearing Numbers 509,992-C, 511,768-B, and 517,420-C, respectively, on the docket  
18 of the First Judicial District Court, parish of Caddo, state of Louisiana.

19 Section 2. The sum of Thirty-Six Thousand Four Hundred Seventy and No/100  
20 (\$36,470.00) Dollars in favor of plaintiff, Jamey L. Salley, individually and on behalf of

1 Levi Salley, is hereby appropriated out of the General Fund of the state of Louisiana for  
2 Fiscal Year 2013-2014 to be used to pay the consent judgment in the suit entitled "Claudia  
3 Salley v. State of Louisiana, Department of Transportation and Development" consolidated  
4 with "Jamey L. Salley v. State of Louisiana, Department of Transportation and  
5 Development" consolidated with "Charles Grippando and Wyna L. Grippando v. State of  
6 Louisiana, Department of Transportation and Development, et al", bearing Numbers  
7 509,992-C, 511,768-B, and 517,420-C, respectively, on the docket of the First Judicial  
8 District Court, parish of Caddo, state of Louisiana.

9 Section 3. The sum of Eight Thousand One Hundred Twenty and No/100  
10 (\$8,120.00) Dollars in favor of plaintiffs, Charles Grippando and Wyna L. Grippando, is  
11 hereby appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2013-  
12 2014 to be used to pay the consent judgment in the suit entitled "Claudia Salley v. State of  
13 Louisiana, Department of Transportation and Development" consolidated with "Jamey L.  
14 Salley v. State of Louisiana, Department of Transportation and Development" consolidated  
15 with "Charles Grippando and Wyna L. Grippando v. State of Louisiana, Department of  
16 Transportation and Development, et al", bearing Numbers 509,992-C, 511,768-B, and  
17 517,420-C, respectively, on the docket of the First Judicial District Court, parish of Caddo,  
18 state of Louisiana.

19 Section 4. This Act shall become effective on July 1, 2013; if vetoed by the  
20 governor and subsequently approved by the legislature, this Act shall become effective on  
21 July 1, 2013, or on the day following such approval by the legislature, whichever is later.
