SCHOOLS/CHOICE: Relative to the Student Scholarships for Educational Excellence (voucher) Program, requires that scholarship recipients annually meet certain criteria for program participation

AN ACT

To amend and reenact R.S. 17:4015(1) and 4018, relative to the Student Scholarships for
Educational Excellence Program; to require that a scholarship recipient meet the
family income level eligibility criteria each year in order to participate in the
program; to require that the state Department of Education annually verify the
eligibility status of each scholarship recipient; and to provide for related matters.
Be it enacted by the Legislature of Louisiana:
Section 1. R.S. 17:4015(1) and 4018 are hereby amended and reenacted to read as
follows:
§4015. Program administration
In administering the program pursuant to this Chapter, the department shall:
(1) Determine student eligibility for scholarships and annually verify the
eligibility status of each scholarship recipient.

§4018. Student eligibility
Scholarship recipients A scholarship recipient shall remain eligible to receive
scholarships a scholarship in each succeeding year that they remain he remains
enrolled in a participating school through grade twelve if he meets the eligibility
criteria defined in R.S. 17:4013(2) relative to family income levels for each year of

**Abstract:** Relative to the voucher program, requires that scholarship recipients annually meet the family income level eligibility criteria for program participation.

<u>Present law</u> relative to the Student Scholarships for Educational Excellence (voucher) Program, defines eligible students as those residing in La. from families with a total income not exceeding 250% of the current federal poverty guidelines who are entering kindergarten, were enrolled in a La. public school that had a letter grade of C, D, or F, or received a scholarship the previous school year. Provides that scholarship recipients shall remain eligible to receive scholarships in each succeeding year that they remain enrolled in a participating school through grade 12. Provides requirements for program administration by the state Dept. of Education, including but not limited to determining student eligibility for scholarships.

<u>Proposed law</u> retains <u>present law</u> except requires that a scholarship recipient meet the <u>present law</u> family income level eligibility criteria each year in order to participate in the program. <u>Proposed law</u> further requires that the state Dept. of Education annually verify the eligibility status of each scholarship recipient.
