4	licenses and special identification cards; to provide for rules and regulations; and to

6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 32:412(L) is hereby enacted to read as follows:
8	§412. Amount of fees; credit or refund; duration of license; disbursement of funds;
9	renewal by mail or electronic commerce of Class "D" or "E" drivers' licenses;
