CRIMINAL/TRIALS: Provides relative to the interruption of time limitations for the commencement of a criminal trial

AN ACT

2	To enact Code of Criminal Procedure Article 579(C), relative to time limitations for
3	criminal trials; to provide relative to the time limitations for the commencement of
4	a criminal trial; to provide relative to the interruption of time limitations for the
5	commencement of a criminal trial; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. Code of Criminal Procedure Article 579(C) is hereby enacted to read as
8	follows:
9	Art. 579. Interruption of time limitation
10	* * *
11	C. If the defendant fails to appear in court pursuant to any provision of this
12	Article and the defendant is subsequently arrested, the periods of limitations
13	established by Article 578 of this Code shall not commence to run anew until the
14	defendant appears in person in open court where the case on the original charges is
15	pending.

Moreno HB No. 512

Abstract: Provides relative to the interruption of time limitations for the commencement of a criminal trial when a defendant fails to appear in court and is subsequently arrested.

<u>Present law</u> provides for the specific time limitations within which a criminal trial must commence.

<u>Present law</u> provides that such time limitations shall be interrupted if any of the following occur:

- (1) The defendant at any time, with the purpose to avoid detection, apprehension, or prosecution, flees from the state, is outside the state, or is absent from his usual place of abode within the state.
- (2) The defendant cannot be tried because of insanity or because his presence for trial cannot be obtained by legal process, or for any other cause beyond the control of the state.
- (3) The defendant fails to appear at any proceeding pursuant to actual notice, proof of which appears of record.

<u>Present law</u> further provides that these periods of limitation shall commence to run anew from the date the cause of interruption no longer exists.

<u>Proposed law</u> provides that if the defendant fails to appear in court pursuant to any provision of <u>present law</u> and the defendant is subsequently arrested, the periods of limitations shall not commence to run anew until the defendant appears in person in open court where the case on the original charges is pending.
