| 12 | community, and faithfully served the people of Slaughter for a century-and-a-half; and         |

| 14 | a strong fortress, the heart of the church has remained the same, shining brightly as a beacon |
| 15 | to the faithful and a haven of friendship to its neighbors; and                                |

| 17 | 16:18, which states, "And I tell you that you are Peter, and on this rock I will build my      |
