A RESOLUTION

WHEREAS, T. Baker Smith, LLC was founded in 1913 in Terrebonne Parish by T. Baker Smith, upon his graduation from Tulane University, as a one-man surveying and civil engineering operation; and

WHEREAS, Baker helped develop and build the early infrastructure in the southeast region of Louisiana, which included roads, bridges, and utility systems; and

WHEREAS, Baker was also a pioneer in the developing oil and gas industry by staking out leases, mapping pipeline rights-of-way, managing permits, and resolving numerous regulatory issues on behalf of some of the industry's largest and most successful companies; and

WHEREAS, Baker's son, Clifford, succeeded him in the family business and expanded operations to include integrated solutions in environmental science and regulatory compliance, and land development; and

WHEREAS, under Clifford's leadership, T. Baker Smith, LLC became a leader in the developing oil and gas industry by providing offshore surveying, civil, structural and coastal engineering, and program management; and

7 Lafayette, Baton Rouge, Shreveport, Houston, and San Antonio, in order to provide services
8 to its growing customer base; and

9 WHEREAS, T. Baker Smith, LLC currently employs more than three hundred
10 professional and support staff working throughout Louisiana and Texas; and

11 WHEREAS, throughout one hundred years and three generations of leadership, T.
12 Baker Smith, LLC and the Smith family remain committed to its founding principles of
13 precision, integrity, and ingenuity in providing tailored solutions to its clients; and

14 WHEREAS, over the last one hundred years, T. Baker Smith, LLC has developed
15 into a top five hundred engineering, architectural, and environmental design firm in the
16 United States, according to the Engineering News Record magazine.
