WEAPONS/HANDGUNS: Prohibits the release of information associated with concealed handgun permits or applications for such permits

AN ACT

2	To enact R.S. 40:1379.3(A)(3), relative to concealed handgun permits; to prohibit the

4	handgun permit applications; to provide for exceptions; to provide for criminal

6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 40:1379.3(A)(3) is hereby enacted to read as follows:
8	§1379.3. Statewide permits for concealed handguns; application procedures;

12	(3)(a) Absent a valid court order requiring the release of information, it shall
13	be unlawful for any employee of the Department of Public Safety and Corrections
14	or any law enforcement officer to intentionally disseminate for publication any
15	information contained in an application for a concealed handgun permit or any
16	information regarding the identity of any person who applied for or received a
17	concealed handgun permit issued pursuant to this Section. A person who violates the
18	provisions of this Subparagraph shall be fined not more than five hundred dollars,
19	imprisoned for not more than six months, or both.

(b) It shall be unlawful for any person other than an employee of the Department of Public Safety and Corrections or a law enforcement officer to release, disseminate, or make public in any manner any information contained in an application for a concealed handgun permit or any information regarding the identity of any person who applied for or received a concealed handgun permit issued pursuant to this Section. Any person who violates the provisions of this Subparagraph shall be fined not more than five thousand dollars, imprisoned, with or without hard labor, for not more than two years, or both.

Thompson HB No. 8

Abstract: Prohibits the release of information contained in concealed handgun permit applications and information regarding the identity of any person who applied for or received such a permit, and provides criminal penalties.

<u>Present law</u> provides for the issuance of concealed handgun permits.

<u>Present law</u> further provides that any information contained in an application for a concealed handgun permit or any information provided in connection with the application submitted to the Dept. of Public Safety and Corrections is confidential, shall not be subject to any public records request, and shall not be considered a public record.

<u>Present law</u> further provides that DPS&C shall not release any list of persons who applied for or received a permit for a concealed handgun.

<u>Proposed law</u> prohibits the release of this information contained in <u>present law</u> and provides penalties as follows:

- (1) An employee of DPS&C or any law enforcement officer who intentionally disseminates for publication information contained in an application for a concealed handgun permit shall be fined not more than \$500, imprisoned for not more than six months, or both. Provides an exception if a court orders the release.
- (2) Any other person who releases, disseminates, or makes public the confidential information shall be fined not more than \$5,000, imprisoned for not more than two years, with or without hard labor, or both.
