FUNDS/FUNDING. Provides that the Louisiana Education Quality Trust Fund shall be known as the "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund." (gov sig)

A.(1) There shall be established in the state treasury as a special permanent trust fund, the Louisiana Education Quality Trust Fund, hereinafter the "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund', henceforth referred to as the "Permanent Trust Fund". After allocation of money to the Bond Security and Redemption Fund as provided in Article VII, Section 9(B) of the constitution, and notwithstanding Article XIV, Section 10 of the constitution, the treasurer shall deposit in and credit to the Permanent Trust Fund all money which is received from the federal government under Section 1337(g) of Title 43 of the United States Code which is attributable to mineral production activity or leasing activity on the Outer Continental Shelf which has been held in escrow pending a settlement between the United States and the state of Louisiana, except the first one hundred million dollars so received; twenty-five percent of the recurring revenues received under Section 1337(g) of Title 43 of the United States Code which are attributable to mineral production activity or leasing activity on the Outer Continental Shelf; twenty-five percent of the interest income earned on investment of monies in the Permanent Trust Fund; and seventy-five percent of realized capital gains and twenty-five percent of dividend income earned on investment of the Permanent Trust Fund. No appropriation shall be made from the Permanent Trust Fund.

§3801.1 "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund"

A. The late Kevin P. Reilly, Sr. served as a member of the Louisiana

House of Representatives from 1972 to 1988. During that time, Representative

Reilly was chairman of the House Committee on Appropriations for fourteen

years of his sixteen-year tenure in the House of Representatives.

B. In 1985, as a member of the House of Representatives, Kevin P. Reilly, Sr. promoted and provided key leadership in the formation of the Louisiana Education Quality Trust Fund, also known as the "8(g) Fund" or the "8(g) Trust Fund". This trust fund earmarks certain oil and natural gas royalties for elementary, secondary, and higher education funding purposes.

The initial trust fund balance was five hundred forty-one million dollars.

C. In 2013, the "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund", has a current balance of one billion one hundred fifty million dollars, of which forty-two million four hundred thousand dollars is forecast to be available for allocation to elementary, secondary, and higher education funding purposes in Fiscal Year 2012-2013. Since inception, the trust fund has provided in excess of one billion four hundred thirty million dollars to a variety of education enhancements and opportunities for Louisiana students at every level of education, which is an increase of one hundred twelve percent over the life of the fund.

(4) Costs attributable to the state treasurer exercising responsibility for the custody, investment, and disbursement of the monies in the Louisiana Education Quality Trust Fund "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund", and the Support Fund are administrative costs properly paid out of Support Fund monies, and shall be paid by appropriation from the Support Fund. Such costs include costs attributable to fees charged by any financial institution for providing custodial services not to exceed two percent of amounts managed costs incurred for outside investment managers for the investment and management of the Permanent Trust Fund not to exceed two percent of amounts managed and other direct costs incurred by the treasurer. Other costs related to these funds shall be paid by appropriation from the state general fund. All appropriations made to, or upon the request of, the state treasurer, related to the management of either the Louisiana Education Quality Trust Fund "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund", or the Support Fund shall be subject to review of the education funds committee.

obligations of a foreign nation which the International Monetary Fund lists as an

1 industrial country, for which investments in and/or business transactions with are not 2 prohibited or restricted by any law, regulation, or rule of the United States or the state of Louisiana, and for which the full faith and credit of such nation has been 3 pledged for the payment of principal and interest; provided that any such security 5 shall be rated at least A- or better by Standard & Poor's Corporation or A3 or better by Moody's, Inc., or an equivalent investment grade by a securities ratings 6 7 organization accepted by the National Association of Insurance Commissioners; and, 8 provided further that the total investment in such foreign securities at any one time 9 shall not exceed five percent of the market value of all investments held by the 10 treasurer in the Louisiana Education Quality Trust Fund "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund", or any other fund or investment of 11 12 funds subject to this investment authority. 13 14 E. Repurchase agreements. (1) In addition to all other investment authority related to the Louisiana 15 Education Quality Trust Fund "Kevin P. Reilly, Sr. Louisiana Education Quality 16 Trust Fund", the state treasurer may enter into direct security repurchase 17 agreements, reverse security repurchase agreements, and securities lending contracts 18 19 in order to generate passive income. 20

B. The purpose of the education funds committee is to oversee the operation of the Louisiana Educational Quality Trust Fund "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund", and the Louisiana Quality Education Support Fund. The education funds committee may recommend revisions in the program and budget of either board. The education funds committee shall forward its recommendations to the appropriate board.

Section 5. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

<u>Present law</u> provides relative to the Louisiana Education Quality Trust Fund which was created as a special permanent trust fund in the state treasury with monies received from the federal government attributable to mineral production or leasing activity on the Outer Continental Shelf. Establishes a Support Fund which shall be available for appropriation for educational purposes, including funding for elementary, secondary, and higher education.

<u>Proposed law</u> provides that the Louisiana Education Quality Trust Fund shall hereinafter also be known as the "Kevin P. Reilly, Sr. Louisiana Education Quality Trust Fund". <u>Proposed law</u> makes name changes, but retains all other provisions of <u>present law</u>. <u>Proposed law</u> makes similar name changes throughout the various statutes where Louisiana Education Quality Trust Fund occurs.

<u>Proposed law</u> provides a brief history of the late Kevin P. Reilly, Sr. who served as a member of the Louisiana House of Representatives from 1972 to 1988, as Chairman of the House Committee on Appropriations for 14 of his 16-year tenure in the House of Representatives, and, in 1985, provided key leadership in the formation of the Louisiana Education Quality Trust Fund, also known as the "8g Fund" or the "8g Trust Fund". Today, the fund has a current balance of \$1.15 billion of which \$42.4 million is forecast to be available for allocation to elementary, secondary, and higher education funding purposes this fiscal year.
