AIRCRAFT/AVIATION. Provides for management, control, and maintenance of the New Orleans Lakefront Airport. (1/1/14)

1	AN ACT
2	To amend and reenact R.S. 38:330.12.1(A) and to enact Part VI of Chapter 2 of Title 2 of
3	the Louisiana Revised Statutes of 1950, to be comprised of R.S. 2:361, relative to the
4	New Orleans Lakefront Airport; to create the New Orleans Lakefront Airport
5	Authority; to transfer the management, control, and maintenance of the New Orleans
6	Lakefront Airport from the Non-Flood Protection Asset Management Authority to
7	the authority; to provide for the powers, duties, and functions of the authority to be
8	exercised through a board of commissioners; to provide for the membership of the
9	board of commissioners; and to provide for related matters.
10	Notice of intention to introduce this Act has been published.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. Part VI of Chapter 2 of Title 2 of the Louisiana Revised Statutes of 1950,
13	comprised of R.S. 2:361, is hereby enacted to read as follows:
14	PART VI. NEW ORLEANS LAKEFRONT AIRPORT AUTHORITY
15	<u>§361. New Orleans Lakefront Airport Authority; creation; board of</u>
16	commissioners; composition; powers, duties, functions
17	A. (1) Notwithstanding any other provision of law to the contrary, the

1	New Orleans Lakefront Airport Authority is hereby created as a body politic
2	and corporate and a political subdivision of the state. The authority shall
3	exercise its duties, functions, powers, and responsibilities through a board of
4	commissioners, hereinafter referred to as the "board".
5	(2) The boundaries of the authority shall be coextensive with the
6	boundaries of the immovable property and facilities of the New Orleans
7	Lakefront Airport.
8	(3) Notwithstanding the provisions of R.S. 33:2740.70.1, no property or
9	facility within the boundaries of the New Orleans Lakefront Airport, and
10	operated, managed, or administered by the authority, shall be subject to the
11	jurisdiction of the Downman Road Economic Development District.
12	B. The domicile of the authority shall be in the parish of Orleans.
13	C. On and after January 1, 2014, the management, control, and
14	maintenance of the New Orleans Lakefront Airport shall be transferred from
15	the Non-Flood Protection Asset Management Authority, created in R.S.
16	38:330.12.1, to the board of commissioners of the New Orleans Lakefront
17	Airport Authority; provided that, the New Orleans Lakefront Airport shall
18	continue to be owned by the Orleans Levee District.
19	D. The board of commissioners of the authority shall be composed of the
20	following members:
21	(1) One member appointed by the chairman of the Non-Flood Protection
22	Asset Management Authority.
23	(2) One member appointed by the governor of the state of Louisiana.
24	(3) One member appointed by the state senators from Senate districts
25	one, three, and four.
26	(4) One member appointed by the state representatives from House
27	districts ninety-seven, ninety-nine, and one hundred.
28	(5) One member appointed by the council members from New Orleans
29	City Council Districts D and E.

1	(6) One member appointed by the Greater New Orleans, Inc.
2	(7) One member appointed by the chairman of the New Orleans Regional
3	Business Park.
4	(8) One member appointed by the chairman of the Southeast Louisiana
5	Flood Protection Authority-East.
6	E. (1) Members of the board shall have experience in airport
7	management, general aviation airports, vending procurement, law, economic
8	development, accounting, or real estate, and shall serve a term of four years.
9	(2) Any vacancy occurring on the board shall be filled in the same
10	manner as the original member for the unexpired portion of the position
11	vacated.
12	(3) A majority of the members shall constitute a quorum for the
13	<u>transaction of official business. All official actions of the authority shall require</u>
14	an affirmative vote of a majority of the members present and voting at any
15	meeting.
16	(4) Members of the board shall not receive any compensation for serving
17	<u>on the board but each member may receive not more than fifty dollars per day</u>
18	for attendance at meetings of the board or its subcommittee meetings provided
19	<u>that the number of days that per diem shall be paid shall not exceed twelve days</u>
20	in any one calendar year. In addition, members may be reimbursed for mileage
21	expenses incurred while in the performance of their official duties at the same
22	mileage rate established by the division of administration for travel by state
23	officials.
24	F. The board shall elect from its members a chairman and a secretary
25	and shall select a vice chairman to serve in the absence of the chairman. The
26	board may employ an executive director and such personnel as may be
27	necessary to implement the provisions of this Section.
28	<u>G. For the purpose of this Section and R.S. 38:330.12.1(A), the authority</u>
29	shall be the successor to the Non-Flood Protection Asset Management

1 Authority, who shall continue the routine operation, management, and 2 maintenance of all properties and facilities of the New Orleans Lakefront 3 Airport until the responsibility for such operation, management, and maintenance is transferred to the authority. 4 5 H. (1) The board may enter into contracts, agreements, or cooperative endeavors of any nature, on behalf of the authority with a state agency, political 6 7 subdivision, or other legal entity or person, or any combination thereof, for the 8 management, operation, and maintenance of the New Orleans Lakefront 9 Airport. 10 (2) The board may conduct a national search for a management firm to conduct the day-to-day operations of the airport. The board may execute a 11 12 contract with the management firm to conduct the day-to-day operation and 13 management of the New Orleans Lakefront Airport. No cost incurred by the 14 board for a management firm contracted to conduct the day-to-day operation and management of the New Orleans Lakefront Airport shall be considered as 15 an eligible cost payable from the aviation account of the Transportation Trust 16 17 Fund. Further, no cost incurred by the board for a management firm shall be considered as a cost eligible for reimbursement under any federal or state 18 19 contract which includes "construction management" or equivalent terminology. 20 I. Except as required by federal law or regulation or the Constitution of 21 Louisiana, all revenues produced from the operation of any facility or 22 improvement at the New Orleans Lakefront Airport shall be collected and 23 retained by the authority. 24 J. The board of commissioners shall provide for the implementation of this Section. 25 26 K. No action taken pursuant to this Section or to any provision of this 27 Part shall impair the obligation of outstanding bonded indebtedness or of any 28 other contract of the Orleans Levee District or the Non-Flood Protection Asset 29 Management Authority or impair the ability of the Orleans Levee District to

4	L. The authority created pursuant to this Part and all members thereof
5	shall be subject to and shall fully comply with the provisions of the open
6	meetings law, R.S. 42:11 et seq., the Code of Governmental Ethics, R.S. 42:1101
7	et seq., and the public records law, R.S. 44:1 et seq., of the state.
8	Section 2. R.S. 38:330.12.1(A) is hereby amended and reenacted to read as follows:
9	§330.12.1. Non-Flood Protection Asset Management Authority; creation;
10	composition; powers, duties, functions
11	A. The Non-Flood Protection Asset Management Authority, hereafter
12	referred to as the "authority", is hereby created as a political subdivision possessing
13	full corporate power to manage, control, regulate, operate, and maintain any non-
14	flood protection facility or improvement asset or function within a levee district
15	within the jurisdiction of a flood protection authority, except as provided in Part
16	VI of Chapter 2 of Title 2 of the Louisiana Revised Statutes of 1950, for the New
17	Orleans Lakefront Airport.

19	Section 3. This Act shall become effective on January 1, 2014.

Morrell (SB 173)

DIGEST

<u>Present law</u> provides for the Non-Flood Protection Asset Management Authority [R.S. 38:330.12.1] to manage and control any non-flood protection asset within a levee district within the territorial jurisdiction of any flood protection authority.

<u>Present law</u> includes all the territory within the geographic boundaries of the New Orleans Lakefront Airport (Airport) within the boundaries of the Downman Road Economic Development District (DREDD) [R.S. 33:2740.70.1].

Proposed law retains present law except for the New Orleans Lakefront Airport.

<u>Proposed law</u> creates the New Orleans Lakefront Airport Authority (NOLAA) as a body corporate and politic and a political subdivision of the state and, effective 1/1/2014, transfers

Page 5 of 7 Coding: Words which are struck through are deletions from existing law; words in **boldface type and underscored** are additions. the management, control, and maintenance of the Airport to the board of commissioners of the authority; provides that the Orleans Levee District continues to own the Airport; excludes the properties and facilities within the boundaries of the Airport which are operated, managed, or administered by the NOLAA from the jurisdiction of DREDD.

<u>Proposed law</u> provides for such airport authority to exercise its duties, functions, powers, and responsibilities through a board of commissioners as follows:

- (1) One member appointed by the chairman of the Non-Flood Protection Asset Management Authority.
- (2) One member appointed by the governor of the state of Louisiana.
- (3) One member appointed by the state senators from Senate districts one, three, and four.
- (4) One member appointed by the state representatives from House districts ninetyseven, ninety-nine, and one hundred.
- (5) One member appointed by the council members from New Orleans City Council District D and E.
- (6) One member appointed by the Greater New Orleans, Inc.
- (7) One member appointed by the chairman of the New Orleans Regional Business Park.
- (8) One member appointed by the chairman of the Southeast Louisiana Flood Protection Authority-East.

<u>Proposed law</u> provides that members appointed have experience in airport management, general aviation airports, vending procurement, law, economic development, accounting, or real estate; that members serve for four years; that a majority of the members constitute a quorum; that official board action requires an affirmative vote by a majority of members present and voting at any meeting; that members receive no compensation for service but may receive per diem not to exceed \$50 for attending board or subcommittee meetings; limits per diem paid to 12 days per year; provides for mileage expense reimbursement when performing official board duties at the rate established for travel by state officials.

<u>Proposed law</u> requires members to elect from its membership: a chairman, a secretary, and a vice chairman, who serves in the chairman's absence; provides for employment of an executive director and such personnel necessary to implement <u>proposed law</u>.

<u>Proposed law</u> provides authority is the successor of the Non-Flood Protection Asset Management Authority; requires the Non-Flood Protection Asset Management Authority continue to manage, operate, and maintain the airport until such responsibility transfers to authority.

<u>Proposed law</u> authorizes the board to enter into contracts, agreements, or cooperative endeavors of any nature, on behalf of the authority with a state agency, political subdivision, or other legal entity or person, or any combination thereof, for the management, operation, and maintenance of the airport; authorizes the board to conduct a national search for a management firm to conduct day-to-day airport operations; further provides that costs associated for a management firm are not eligible for payment from the aviation account of the Transportation Trust Fund or for reimbursement under any federal or state contract which includes "construction management" or equivalent terminology.

<u>Proposed law</u> provides that all revenues produced from the operation of any facility or improvement at the airport be collected and retained by the authority, except as required by

Proposed law authorizes the board to implement provisions of proposed law.

<u>Proposed law</u> prohibits any action which impairs obligations of outstanding bonded indebtedness or contracts of the Orleans Levee District or the Non-Flood Protection Asset Management Authority or which impairs the ability of the Orleans Levee District to satisfy any legal action or claim pending against the levee district on January 1, 2014, or the Non-Flood Protection Asset Management Authority on January 1, 2014.

<u>Proposed law</u> requires that NOLAA and all members comply with open meetings law, Code of Governmental Ethics, and public records law.

Effective January 1, 2014.

(Amends R.S. 38:330.12.1(A); adds R.S. 2:361)

Summary of Amendments Adopted by Senate

Committee Amendments Proposed by Senate Committee on Transportation, Highways, and Public Works to the original bill

- 1. Provides that Orleans Levee District continues to own the New Orleans Lakefront Airport.
- 2. Excludes New Orleans Lakefront Airport from jurisdiction of the Downman Road Economic Development District.
- 3. Changes membership of the board and removes requirements for Senate confirmation of board members and limits per diem to no more than twelve days per year.
- 4. Requires that board members have experience in airport management, general aviation airports, vending procurement, law, economic development, accounting, or real estate.
- 5. Provides that costs associated with a management firm for day-to-day operations are not eligible for payment from the aviation account of the Transportation Trust Fund or for reimbursement under any federal or state contract which includes "construction management" or equivalent terminology.
- 6. Requires NOLAA and members to comply with open meetings law, Code of Governmental Ethics, and public records law.

Senate Floor Amendments to engrossed bill

- 1. Makes Legislative Bureau changes.
- 2. Adds a member appointed by the Senator of District One to the board.
- 3. Changes the member appointed by the mayor of New Orleans to a member appointed by Greater New Orleans, Inc.
