**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Health and Welfare to Original House Bill No. 393 by Representative Anders

**1** AMENDMENT NO. 1

2 On page 1, line 2, delete "460.34," and insert in lieu thereof "460.35,"

**3** AMENDMENT NO. 2

4 On page 1, line 6, after "drugs;" delete the remainder of the line and delete lines 7 and 8 in  
5 their entirety

**6** AMENDMENT NO. 3

7 On page 1, at the beginning of line 9, delete "certain legislative committees;" and insert in  
8 lieu thereof "to provide for prepaid coordinated care network pharmaceutical and  
9 therapeutics committees;"

**10** AMENDMENT NO. 4

11 On page 1, line 11, after "rules;" and before "and to provide" insert "to provide for  
12 exemptions;"

**13** AMENDMENT NO. 5

14 On page 1, line 15, delete "460.34," and insert in lieu thereof "460.35,"

**15** AMENDMENT NO. 6

16 On page 2, delete lines 1 and 2 in their entirety

**17** AMENDMENT NO. 7

18 On page 2, at the beginning of line 3, change "(3)" to "(2)"

**19** AMENDMENT NO. 8

20 On page 2, at the beginning of line 7, change "(4)" to "(3)"

**21** AMENDMENT NO. 9

22 On page 2, between lines 8 and 9, insert the following:

23 "(4) "Prepaid coordinated care network" means a private entity that contracts  
24 with the department to provide Medicaid benefits and services to enrollees of the  
25 Medicaid coordinated care program known as "Bayou Health" in exchange for a  
26 monthly prepaid capitated amount per member."

**27** AMENDMENT NO. 10

28 On page 2, delete lines 15 through 29 in their entirety and delete pages 3 through 5 in their  
29 entirety

1 AMENDMENT NO. 11

2 On page 6, delete lines 1 through 3 in their entirety and insert in lieu thereof the following:

3 "§460.32. Prepaid coordinated care networks; pharmaceutical and therapeutics  
4 committees  
5 On or before January 1, 2014, each prepaid coordinated care network shall  
6 form a body to be designated as a "Pharmaceutical and Therapeutics Committee"  
7 which shall develop a drug formulary and preferred drug list for the prepaid  
8 coordinated care network. Each Pharmaceutical and Therapeutics Committee  
9 created pursuant to the provisions of this Section shall meet no less frequently than  
10 semiannually in Baton Rouge, Louisiana. Such meetings shall be open to the public  
11 and shall allow for public comment prior to voting by the committee on any change  
12 in the preferred drug list or formulary."

13 AMENDMENT NO. 12

14 On page 6, delete line 6 in its entirety and insert in lieu thereof "a two-page prior  
15 authorization form, excluding guidelines or information, duly promulgated by the  
16 department in"

17 AMENDMENT NO. 13

18 On page 7, delete lines 13 through 17 and insert in lieu thereof the following:

19 "§460.35. Exemptions  
20 The provisions of this Part shall not apply to any entity that contracts with the  
21 department to provide fiscal intermediary services in processing claims of health care  
22 providers.

23 Section 2. This Act shall become effective on January 1, 2014."
