RESEARCH & DEVELOPMENT: Establishes the MediFund for statewide advancement of biosciences and medical centers of excellence

AN ACT

2	To enact R.S. 36:651(CC), 802.23, and Chapter 37-A of Title 51 of the Louisiana Revised
3	Statutes of 1950, to be comprised of R.S. 51:2211 through 2216, and to repeal
4	Chapter 37 of Title 51 of the Louisiana Revised Statutes of 1950, comprised of R.S.
5	51:2201 through 2205, relative to a fund for support of scientific research and
6	development; to establish the MediFund as a special fund for advancement of
7	biosciences and medical centers of excellence; to provide for purposes of the fund;
8	to create and provide for the composition of a governing board for the fund; to
9	provide for duties and authority of the governing board; to provide guidelines for
10	programs and projects to be funded by the MediFund; to establish a termination date
11	for the MediFund; to repeal provisions relative to the Dedicated Research Investment
12	Fund; and to provide for related matters.
13	Be it enacted by the Legislature of Louisiana:
14	Section 1. R.S. 36:651(CC) and 802.23 are hereby enacted to read as follows:
15	§651. Transfer of boards, commissions, departments, and agencies to Department
16	of Education; boards, commissions, and agencies within Department of

5	§802.23. Transfer; MediFund Board
6	The MediFund Board, transferred by the provisions of R.S. 36:651(CC), is
7	transferred to and placed within the Board of Regents and shall continue to be
8	composed and selected as provided by law, and shall continue to exercise all of the
9	powers, duties, functions, and responsibilities provided or authorized by the
10	constitution or laws which are in the nature of policymaking, rulemaking, regulation,
11	enforcement, or adjudication and also shall continue to exercise all advisory powers,
12	duties, functions, and responsibilities provided by law. Such powers, duties,
13	functions, and responsibilities shall be exercised independently of the commissioner
14	of higher education.
15	Section 2. Chapter 37-A of Title 51 of the Louisiana Revised Statutes of 1950,
16	comprised of R.S. 51:2211 through 2216, is hereby enacted to read as follows:
17	CHAPTER 37-A. LOUISIANA MEDIFUND
18	§2211. Purpose and goals
19	A. The provisions of this Chapter establish the MediFund as a special fund
20	within the state treasury to support advancement of biosciences and medical centers
21	of excellence in Louisiana. The governing board of the MediFund shall endeavor to
22	achieve this purpose by coordinating and deploying public and private resources to
23	strategically develop and enhance this state's competitiveness in biosciences and
24	medical centers of excellence.
25	B. The goals of the MediFund shall include all of the following:
26	(1) Create regional and national medical centers of excellence for
27	biosciences in order to promote destination health care.
28	(2) Contribute to improvement of health outcomes for consumers of health
29	care services in Louisiana.

1	(3) Support strategic research and clinical partnerships.
2	(4) Facilitate a competitive process for funding program proposals and
3	projects based on objectively determined potential for positive economic
4	development impact in terms of job creation and generation of tax revenue.
5	§2212. Definitions
6	As used in this Chapter, the following terms shall have the meanings ascribed
7	to them below:
8	(1) "Biosciences" means any of the branches of natural science dealing with
9	the structure and behavior of living organisms, including but not limited to
10	translational and regenerative research, development, manufacture, testing,
11	marketing or distribution of pharmaceuticals, biotechnology products, biotechnology
12	and health-related software, and medical devices that will eventually be used by
13	health care providers to treat, cure, prevent, or mitigate disease or health conditions.
14	(2) "Board" means the MediFund governing board.
15	(3) "Department" means the Department of Health and Hospitals.
16	(4) "Fund" means the MediFund created by the provisions of this Chapter.
17	§2213. MediFund; creation
18	A. The MediFund, hereafter referred to as the "fund", is hereby created as
19	a special fund in the state treasury. The source of monies for the fund may include
20	but shall not be limited to any appropriation by the legislature, including federal
21	funds; any public or private donations, gifts, or grants from individuals, corporations,
22	nonprofit organizations, or other business entities; venture capital; and any other
23	monies which may be provided by law.
24	B. All money received by the fund, except as otherwise provided by Article
25	VII, Section 9(B) of the Constitution of Louisiana relative to the Bond Security and
26	Redemption Fund, shall be deposited immediately upon receipt into the state
27	treasury.
28	C. The monies in the fund shall be invested by the state treasurer in the same
29	manner as monies in the state general fund. Interest earned on the investment of

3	unexpended and unencumbered monies in the fund at the end of each fiscal year shall
4	remain in the fund.
5	D. The monies in the fund shall be used solely for the purposes provided in
6	this Chapter.
7	§2214. Governing board; authority; duties
8	A. There is hereby established within the department the MediFund Board,
9	hereafter referred to as the "board", which shall be composed as provided in
10	Subsection B of this Section. The secretary of the department shall take such actions
11	as are necessary to have the roster of initial board members compiled on or before
12	September 1, 2013, and to convene the first meeting of the board on or before
13	November 1, 2013.
14	B. The board shall be composed of thirteen members, none of whom may be
15	employed by an entity which is eligible to receive MediFund grants, as follows:
16	(1) One member appointed by the commissioner of higher education.
17	(2) Four members appointed by the governor who each possess significant
18	experience in bioscience, translational, or regenerative research; or biomedical
19	administration.
20	(3) One member appointed by the secretary of the Department of Health and
21	Hospitals.
22	(4) One member appointed by the secretary of the Louisiana Economic
23	Development.
24	(5) One member appointed by the speaker of the House of Representatives.
25	(6) One member appointed by the president of the Senate.
26	(7) Three members appointed in the number of one member apiece by each
27	of the following organizations which collectively represent the top three regions of
28	the state for National Institutes of Health funding amounts:
29	(a) Baton Rouge Area Chamber.

3	(8) One member appointed by the Experimental Program to Stimulate
4	Competitive Research (EPSCoR) Committee of the Board of Regents.
5	C. Board members shall serve without compensation and shall receive no per
6	diem but may be reimbursed for their actual expenses incurred while in attendance
7	at board meetings or in the conduct of board business.
8	D. A simple majority of the members of a board shall constitute a quorum
9	for the transaction of business. At its first meeting and annually thereafter with at
10	least two-thirds of the members present, the board shall elect one of its members as
11	chairman, one member as vice chairman, and one member as secretary.
12	E. The board shall adopt bylaws to provide for the governance of the board.
13	The bylaws shall include but not be limited to procedures and grounds for the
14	removal of any board member. Grounds for removal shall include conviction of a
15	felony and may include failure to meet board attendance rules as provided in the
16	bylaws.
17	F. Procedures for filling a vacancy created by the removal, resignation, or
18	death of any board member prior to the end of the board member's term shall follow
19	those used for initial appointments.
20	G. The board shall have the authority to take all of the following actions:
21	(1) Form a Research Advisory Council composed of representatives of the
22	BioDistrict New Orleans, Pennington Biomedical Research, and the BioMedical
23	Research Foundation of Northwest Louisiana to determine priority research
24	concentrations and commercialization strategies, or other matters as may be
25	requested by the board.
26	(2) Form special committees, advisory councils, or similar bodies to study
27	and make policy recommendations to the board concerning priority research areas,
28	research commercialization strategies, or other matters as may be requested by the
29	board.

1	(3) Enter into contracts as necessary for development of proposal evaluation
2	criteria, coordination of a proposal evaluation process, or other functions related to
3	evaluation of funding proposals and applications for funding submitted to the board.
4	(4) Promulgate all such rules, in accordance with the Administrative
5	Procedure Act, as are necessary to carry out the programs and functions of the
6	MediFund.
7	H. On or before January 1, 2014, and annually thereafter, the board shall
8	submit to the House and Senate committees on health and welfare a report which
9	addresses funding activities undertaken by the MediFund in the most recent one-year
10	period and any other information which the board deems appropriate to convey a
11	clear understanding of the operations and impact of the MediFund on
12	commercialization of bioscience research, improvement of health outcomes, number
13	of new jobs created, and total economic benefit.
14	§2215. MediFund program guidelines
15	A. The board shall promulgate rules and regulations governing the use of
16	monies of the MediFund and shall adopt policies for governance of any program or
17	funding action that it implements prior to initiation of the program or funding action.
18	The rules and regulations of the MediFund shall establish a maximum amount or
19	percentage of total funds that may be awarded to any individual project recipient or
20	that may be utilized by the board for administrative expenses. The rules and
21	regulations provided for in this Section shall be adopted in accordance with the
22	Administrative Procedure Act.
23	B. The board shall delineate the programs which it implements and the
24	functions that each program fulfills. For this purpose, the board shall implement a
25	tiered system of funding to consist of awards known as "planning grants", "program
26	grants", and "proof of concept grants", with corresponding monetary ranges for each
27	grant type.
28	C. Grants and other funding of the MediFund shall be committed only to
29	public or not-for-profit entities.

1	D. The board shall apply the following guidelines for proposal selection,
2	project monitoring, and matching funds:
3	(1) Proposal solicitation, review, selection, and monitoring processes shall
4	be implemented in such a manner as to ensure efficient operations and the attainment
5	of the following objectives:
6	(a) A proposal solicitation process which involves publicizing of board
7	programs among academic, clinical, and research institutions and within relevant
8	industries.
9	(b) A proposal review process which assures complete, competent, and

21	cash, in-kind donations, other grant monies received to support the respective
22	program or project funded by the MediFund, and any other resources as the board
23	deems appropriate.
24	§2216. Termination
25	The provisions of this Chapter shall terminate on December 31, 2018.
26	Section 3. Chapter 37 of Title 51 of the Louisiana Revised Statutes of 1950,
27	comprised of R.S. 51:2201 through 2205, is hereby repealed in its entirety.
28	Section 4. This Act shall become effective upon signature by the governor or, if not
29	signed by the governor, upon expiration of the time for bills to become law without signature

- 1 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 2 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 3 effective on the day following such approval.

Abstract: Establishes the MediFund for statewide advancement of biosciences and medical centers of excellence.

<u>Proposed law</u> establishes the MediFund as a special fund within the state treasury to support advancement of biosciences and medical centers of excellence in Louisiana.

<u>Proposed law</u> provides that the goals of the MediFund shall include:

- (1) Create regional and national medical centers of excellence for biosciences in order to promote destination health care.
- (2) Contribute to improvement of health outcomes for consumers of health care services in Louisiana.
- (3) Support strategic research and clinical partnerships.
- (4) Facilitate a competitive process for funding program proposals and projects based on objectively determined potential for positive economic development impact in terms of job creation and generation of tax revenue.

<u>Proposed law</u> creates the MediFund Board within the Board of Regents and provides the board with independent rulemaking authority. Requires the secretary of DHH to have the roster of initial board members compiled on or before Sept. 1, 2013, and to convene the first meeting of the board on or before Nov. 1, 2013.

<u>Proposed law</u> provides that the board shall be composed of 13 members, none of whom may be employed by an entity which is eligible to receive MediFund grants, as follows:

- (1) One member appointed by the commissioner of higher education.
- (2) Four members appointed by the governor who each possess significant experience in bioscience, translational, or regenerative research; or biomedical administration.
- (3) One member appointed by the secretary of DHH.
- (4) One member appointed by the secretary of LED.
- (5) One member appointed by the speaker of the House of Representatives.
- (6) One member appointed by the president of the Senate.

- (7) Three members appointed in the number of one member apiece by each of the following organizations which collectively represent the top three regions of the state for National Institutes of Health funding amounts:
 - (a) Baton Rouge Area Chamber.
 - (b) Greater New Orleans, Inc.
 - (c) North Louisiana Economic Partnership.
- (8) One member appointed by the Experimental Program to Stimulate Competitive Research (EPSCoR) Committee of the Board of Regents.

<u>Proposed law</u> provides that board members shall serve without compensation and shall receive no per diem, but may be reimbursed for their actual expenses incurred while in attendance at board meetings or in the conduct of board business.

<u>Proposed law</u> requires the board to adopt bylaws to provide for the governance of the board. Provides that the bylaws shall include procedures and grounds for the removal of any board member. Further provides that grounds for removal shall include conviction of a felony and may include failure to meet board attendance rules as provided in the bylaws.

<u>Proposed law</u> authorizes the board to take all of the following actions:

- (1) Form a Research Advisory Council composed of representatives of the BioDistrict New Orleans, Pennington Biomedical Research, and the BioMedical Research Foundation of Northwest Louisiana to determine priority research concentrations and commercialization strategies, or other matters as may be requested by the board.
- (2) Form special committees, advisory councils, or similar bodies to study and make policy recommendations to the board concerning priority research areas, research commercialization strategies, or other matters as may be requested by the board.
- (3) Enter into contracts as necessary for development of proposal evaluation criteria, coordination of a proposal evaluation process, or other functions related to evaluation of funding proposals and applications for funding submitted to the board.
- (4) Promulgate all such rules, in accordance with the Administrative Procedure Act, as are necessary to carry out the programs and functions of the MediFund.

<u>Proposed law</u> provides that on or before Jan. 1, 2014, and annually thereafter, the board shall submit to the legislative committees on health and welfare a report which addresses funding activities undertaken by the MediFund in the most recent one-year period, and any other information which the board deems appropriate to convey a clear understanding of the operations and impact of the MediFund on commercialization of bioscience research, improvement of health outcomes, number of new jobs created, and total economic benefit.

<u>Proposed law</u> requires the board to promulgate rules and regulations governing the use of monies of the MediFund and adopt policies for governance of any program or funding action that it implements prior to initiation of the program or funding action. Requires the rules and regulations of the MediFund to establish a maximum amount or percentage of total funds that may be awarded to any individual project recipient or that may be utilized by the board for administrative expenses.

<u>Proposed law</u> requires the board to delineate the programs which it implements and the functions that each program fulfills. For this purpose, <u>proposed law</u> provides that the board shall implement a tiered system of funding to consist of awards known as "planning grants",

"program grants", and "proof of concept grants" with corresponding monetary ranges for each grant type.

<u>Proposed law</u> stipulates that grants and other funding of the MediFund be committed only to public or not-for-profit entities.

<u>Proposed law</u> requires the board to apply the following guidelines for proposal selection, project monitoring, and matching funds:

- (1) Proposal solicitation, review, selection, and monitoring processes shall be implemented in such a manner as to ensure efficient operations and the attainment of the following objectives:

Proposed law provides that proposed law shall terminate on Dec. 31, 2018.

<u>Proposed law</u> repeals <u>present law</u> which creates the Dedicated Research Investment Fund for support of biomedical and biotechnological research and development.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Adds R.S. 36:651(CC), 802.23, and R.S. 51:2211-2216; Repeals R.S. 51:2201-2205)

Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Appropriations</u> to the <u>original</u> bill.

- 1. Changes the placement of the MediFund Board <u>from</u> the Department of Health and Hospitals <u>to</u> the Board of Regents.
- 2. Changes definition of "biosciences".
- 3. Adds venture capital as a source of funding that can be deposited in the MediFund.
- 4. Increases MediFund Board membership <u>from</u> 11 <u>to</u> 13 by adding one member appointed by the commissioner of higher education and one member appointed by the Experimental Program to Stimulate Competitive Research (EPSCoR) Committee of the Board of Regents.
- 5. Provides the MediFund Board with additional authority, including forming a Research Advisory Council.
- 6. Adds "proof of concept grants" as an additional award type.
- 7. Deletes threshold for matching resource requirement.
