Provides for the qualifications and duties of the medical director within the office of workers' compensation. (8/1/13)

Proposed law defines "medical director" in the Office of Workers' Compensation to mean a physician that meets the following criteria: (1) licensed to practice medicine in Louisiana; (2) chosen by the director of the Office of Workers' Compensation; and (3) full-time public employee of the Office of Workers' Compensation that will not engage in the practice of medicine outside of the Office of Workers' Compensation. Proposed law provides that the following medical treatment shall not need the approval of the medical director: (1) 12 routine office visits with injured workers' treating physician each year; and (2) frequency of prescribed physical therapy treatments as longs a total number of visits does not exceed the amount allowed until the medical treatment schedule.
