TRANSPORTATION DEPT: Requires DOTD to provide maps of highway priority projects by House and Senate districts to all members of the legislature

AN ACT

2	To amend and reenact R.S. 48:231(A), relative to the highway priority construction
3	program; to provide for the presentation of the proposed program of construction to
4	members of the legislature; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 48:231(A) is hereby amended and reenacted to read as follows:
7	§231. Final construction program for current fiscal year; public hearings; Joint
8	Highway Priority Construction Committee; reports; review by legislature;
9	restrictions on legislature
10	A.(1) Beginning on October 1, 2010, and not later than October 1 first of each
11	year thereafter, the department shall provide a proposed program of construction for
12	the coming fiscal year to the Joint Highway Priority Construction Committee.
13	(2) The committee shall hold public hearings in each highway district for the
14	purpose of reviewing priorities for the coming fiscal year.
15	(3) At each public hearing, the department shall provide each House of
16	Representatives and Senate member with a map indicating the following regarding
17	projects within their respective House or Senate district:
18	(a) All projects proposed for construction within their district for the coming
19	fiscal year.
20	(b) All completed projects within their district for the three previous fiscal
21	<u>years.</u>

1	(4) The department shall make the maps required to be provided to members
2	of the legislature pursuant to Paragraph (3) of this Subsection available to any person
3	upon request following the public hearings.
4	(5) A report based on the testimony received at said the hearings shall be sent
5	to the department. The department then shall shall then create the final construction
6	program for the coming fiscal year for submission to the legislature.
7	(6) When this final construction program is communicated to the legislature
8	for funding for the coming fiscal year, any project which the legislature determines
9	is not in the proper order of priority in accordance with the factors stated in R.S.
10	48:229 may be deleted by the legislature. However, the legislature shall not add any
11	projects to this final construction program, nor shall the legislature make
12	substitutions for projects which have been removed.

Montoucet HB No. 721

Abstract: Requires the Dept. of Transportation and Development to provide each House and Senate member a map indicating all projects proposed for construction within their respective district for the coming fiscal year and all completed projects within their respective district for the previous three fiscal years.

<u>Present law</u> provides that beginning on Oct. 1, 2010, and not later than Oct. 1 of each year thereafter, the Dept. of Transportation and Development shall provide a proposed program of construction for the coming fiscal year to the Joint Highway Priority Construction Committee. The committee is required hold public hearings in each highway district for the purpose of reviewing priorities for the coming fiscal year.

<u>Proposed law</u> requires the Dept. of Transportation and Development to provide each House and Senate member a map indicating all projects proposed for construction within their respective districts for the coming fiscal year and all completed projects within their respective districts for the previous three fiscal years.

<u>Proposed law</u> requires the Dept. of Transportation and Development to make these maps available to House and Senate members at the public hearings required by <u>present law</u> and be made available to any person upon request following the public hearings.
