However, any monies collected for delinquent debt as a result of nonpayment of tax liabilities pursuant to Title 47 of the 11 Louisiana Revised Statutes of 1950, as amended, after deposit into the state general 12 fund, the first five million dollars shall be appropriated by the legislature beginning 13 in Fiscal Year 2013-2014, and for four consecutive fiscal years thereafter, to the 14 15 Office of State Police for a training academy class."
