**CLERKS OF COURT** REF +\$19,000 LF EX See Note Page 1 of 1 Provides for the payment of medical insurance premiums of certain retirees of the clerk of court's office in St. James Parish. (8/1/13)

Purpose of Bill: Requires the St. James Parish Clerk of Court to pay, provided sufficient amounts are available, 100% of the premium costs of the group life and accidental death, health, accident, dental, hospital, surgical, or other medical expense insurance for any clerk or employee that retires from the St. James Clerk of Court's office who is entitled to receive monthly benefits from the LA Clerks of Court Retirement and Relief Fund who has 20 years of full-time service with the Clerk of Court's office in St. James Parish and who is at least 55 years of age.

## **EXPENDITURE EXPLANATION**

This measure may increase local expenditures of the St. James Parish Clerk of Court by \$19,000 by fiscal year 2016-2017.

An official with the St. James Parish Clerk of Court based this estimate on the following:

- 1. The full premium for one qualifying employee not eligible for Medicare is included each year at \$9,779 per year.
- 2. The supplemental premiums for two additional employees both eligible for Medicare are included beginning in 2016-17 at approximately \$3,650 per year each.
- 3. An estimated premium increase of 11.4% in 2016-17 is included based on the past experience of the Clerk's Office.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
