Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1	AN ACT		
2	To enact R.S. 47:463.160 and 463.161, relative to motor vehicle special prestige license		
3	plates; to provide for creation, issuance, and design of such license plates; to provide		
4	relative to the fee and distribution of fees for such plates; to authorize the		
5	promulgation of rules and regulations relative to the creation and implementation of		
6	a special prestige license plate; and to provide for related matters.		
7	Be it enacted by the Legislature of Louisiana:		
8	Section 1. R.S. 47:463.160 and 463.161 are hereby enacted to read as follows:		
9	<u>§463.160. Special prestige license plates; "I'm Cajun"</u>		
10	A. The secretary of the Department of Public Safety and Corrections shall		
11	establish a special prestige motor vehicle license plate to be known as the "I'm		
12	Cajun" plate, provided there is a minimum of one thousand applicants for such plate.		
13	These license plates shall be restricted to use on passenger cars, pickup trucks,		
14	recreational vehicles, and vans.		
15	B. The plate shall be of a color and design selected by the Council for the		
16	Development of French in Louisiana, provided that it is in compliance with R.S.		
17	47:463(A)(3). The design shall include the phrase "I'm Cajunand proud" and shall		
18	also include a prominent image celebrating the Cajun culture.		
19	C. The prestige license plate shall be issued, upon application, to any citizen		
20	of Louisiana in the same manner as any other motor vehicle license plate.		
21	D. The department shall collect an annual royalty fee of fifteen dollars for		
22	this special prestige license plate, which shall be disbursed in accordance with		
23	Subsection E of this Section. This fee shall be in addition to the standard motor

13	Creole" plate, provided there is a minimum of one thousand applicants for such plate.	
14	These license plates shall be restricted to use on passenger cars, pickup trucks,	
15	recreational vehicles, and vans.	
16	B. The plate shall be of a color and design selected by the Council for the	
17	Development of French in Louisiana, provided that it is in compliance with	
18	R.S.47:463(A)(3). The design shall include the phrase "I'm Creoleand proud" and	
19	shall also include a prominent image celebrating the Creole culture.	
20	C. The prestige license plate shall be issued, upon application, to any citizen	
21	of Louisiana in the same manner as any other motor vehicle license plate.	
22	D. The department shall collect an annual royalty fee of fifteen dollars for	
23	this special prestige license plate, which shall be disbursed in accordance with	
24	Subsection E of this Section. This fee shall be in addition to the standard motor	
25	vehicle license tax imposed by Article VII, Section 5 of the Constitution of	
26	Louisiana, and a handling fee of three dollars and fifty cents for each plate to be	
27	retained by the department to offset a portion of administrative costs.
