EXPENDITURE EXPLANATION

Implementation of the proposed legislation will require minor changes to the Secretary of State's computer system. The changes are anticipated to have a minimal fiscal impact and will be provided for with existing resources.

REVENUE EXPLANATION

The proposed legislation is anticipated to result in an annual increase of \$2.8 M in fees and self-generated revenue for the Commercial Division of the Secretary of State's office. The existing and proposed amount of each fee increase along with the total amount of revenue to be generated annually for each fee is shown below.

FILINGS:

- \$778,650 - domestic limited liability companies (\$25 increase from \$75 to \$100)
- \$67,230 - domestic corporations and domestic nonprofit corporations (\$15 increase from \$60 to \$75)
- \$51,250 - foreign corporations (\$25 increase from \$100 to \$125)
- \$48,225 - foreign limited liability companies (\$25 increase from \$125 to \$150)

ANNUAL REPORTS:

- \$615,685 - domestic limited liability companies (\$5 increase from \$25 to \$30)
- \$278,790 - domestic corporations (\$5 increase \$25 to \$30)
- \$93,385 - domestic nonprofit corporations (\$5 increase from \$5 to \$10)
- \$98,675 - foreign corporations (\$5 increase from \$25 to \$30)
- \$49,670 - foreign limited liability companies (\$5 increase from \$25 to \$30)
