DISTRICTS/HOSPITAL SERVC: Requires voter approval of the lease of hospitals in Jefferson Parish hospital service districts unless all are leased to a single lessee

AN ACT

2 To amend and reenact R.S. 46:1064.2, relative to hospital service districts in Jefferson 3 Parish; to provide relative to the lease of a hospital owned by any such district; to require voter approval of such leases; to provide for an exception with respect to 4 5 voter approval; and to provide for related matters. Notice of intention to introduce this Act has been published 6 7 as provided by Article III, Section 13 of the Constitution of 8 Louisiana. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. R.S. 46:1064.2 is hereby amended and reenacted to read as follows: 11 §1064.2. Hospital service districts in Jefferson Parish; sale or lease of hospitals 12 A.(1) Notwithstanding any provisions of law to the contrary and except as 13 provided in Subsection D of this Section, the sale or lease of any hospital owned by 14 a hospital service district in Jefferson Parish shall be in accordance with the 15 provisions of this Subsection Section. The provisions of this Subsection Section 16 shall apply to the sale or lease of a hospital pursuant to authority granted by R.S. 17 33:4341 and any other authority granted by law. 18 (2)B. The governing authority of the hospital service district shall submit a 19 proposition to approve the sale <u>or lease</u> of the hospital to the voters of the hospital 20 service district in an election held for that purpose.

The hospital service district shall sell or lease the hospital only if the 2 proposed sale or lease is approved by a majority of the qualified electors of the 3 hospital service district voting on the proposition at an election held for that purpose 4 and conducted in accordance with the Louisiana Election Code. 5 B. The provisions of R.S. 33:4341 shall not apply to the lease of a hospital by a hospital service district in Jefferson Parish; the governing authority of the 6 7 district may, by its own action, approve the lease of a hospital. 8 D. The requirements of this Section and R.S. 33:4341 for voter approval of 9 a lease of a hospital are not applicable to a lease of all hospital service district 10 facilities in Jefferson Parish to a single lessee.

Abstract: Requires voter approval of the lease of hospitals in Jefferson Parish hospital service districts unless all are leased to a single lessee.

<u>Present law</u> establishes the procedure for the sale of a hospital owned by a hospital service district in Jefferson Parish. Requires the governing authority of the hospital service district to submit a proposition to approve the sale of the hospital to the voters of the district. The sale of the hospital can only proceed if a majority of the voters of the district vote to approve the sale or lease. <u>Proposed law</u> retains <u>present law</u>.

<u>Proposed law</u> provides that the lease of a hospital is also subject to voter approval; however, provides that voter approval is not required if all of the hospital service district facilities in the parish are to be leased to a single lessee.

<u>Present law</u> (R.S. 33:4341) requires voter approval for the sale or lease of revenue-producing property by most local governments.

<u>Present law</u> provides that this requirement does not apply to the lease of a hospital by a hospital service district in Jefferson Parish. Specifically authorizes the governing authority of a district to approve such a lease by its own action. <u>Proposed law</u> deletes <u>present law</u>.

<u>Proposed law</u> provides that R.S. 33:4341 is not applicable to the lease of hospitals in Jefferson Parish only if all of the facilities in Jefferson Parish are to be leased to a single lessee.
