HOUSE BILL NO. 372

DISTRICTS/HOSPITAL SERVC: Provides for a local referendum on the question of selecting a lessee for hospitals in Jefferson Parish

To amend and reenact R.S. 46:1064.2(B) and to enact R.S. 46:1064.2(C), relative to hospital
service districts in Jefferson Parish; to provide relative to the lease of hospitals
owned by such districts; to provide with respect to the process by which the lessee
is selected; and to provide for related matters.
Notice of intention to introduce this Act has been published
as provided by Article III, Section 13 of the Constitution of
Louisiana.
Be it enacted by the Legislature of Louisiana:
Section 1. R.S. 46:1064.2(B) is hereby amended and reenacted and R.S.
46:1064.2(C) is hereby enacted to read as follows:
§1064.2. Hospital service districts in Jefferson Parish; sale or lease of hospitals
* * *
B. The provisions of R.S. 33:4341 shall not apply to the lease of a hospital
by a hospital service district in Jefferson Parish; the governing authority of the
district may, by its own action, approve the lease of a hospital.
C. Notwithstanding any provisions of law to the contrary, the lease of any
hospital owned by a hospital service district in Jefferson Parish shall be in
accordance with the provisions of this Subsection. The provisions of this

1	Subsection shall apply to the lease of a hospital pursuant to authority granted
2	by R.S. 33:4341 and any other authority granted by law.
3	(1) No lease shall be entered into unless all hospital facilities in Jefferson
4	Parish will be leased to a single lessee.
5	(2) If hospitals owned by hospital service districts in Jefferson Parish are to
6	be leased, the governing authority of the parish shall select two potential lessees and
7	call an election in which the electors of Jefferson Parish shall select the lessee.
8	(3) The governing authority shall enter a lease for all hospital facilities in the
9	parish with the lessee that receives the majority of the votes cast.

Abstract: Provides procedures for lease of hospitals owned by hospital service districts in Jefferson Parish.

<u>Present law</u> establishes the procedure for the sale of a hospital owned by a hospital service district in Jefferson Parish. Requires the governing authority of the hospital service district to submit a proposition to approve the sale of the hospital to the voters of the district. The sale of the hospital can only proceed if a majority of the voters of the district vote to approve the sale.

<u>Present law</u> (R.S. 33:4341) requires voter approval for the sale or lease of revenue-producing property by most local governments. Further provides that this requirement does not apply to the lease of a hospital owned by a hospital service district in Jefferson Parish. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> authorizes the governing authority of a district to approve such a lease by its own action. <u>Proposed law</u> deletes <u>present law</u>.

<u>Proposed law</u> establishes the procedure for the lease of hospitals owned by hospital service districts in Jefferson Parish. Provides that no lease shall be entered into unless all hospital facilities in Jefferson Parish will be leased to a single lessee. Further provides that, if any such hospital is leased, the governing authority shall select two potential lessees and call an election in which the electors of Jefferson Parish shall select the lessee. Requires the governing authority to enter a lease for all hospital facilities in the parish with the lessee selected by the electors of Jefferson Parish.
