6	Section 1. R.S. 17:174(A) is hereby amended and reenacted and R.S. 17:3996(B)(34)

9	A.(1) Notwithstanding any other law to the contrary, on and after September
10	15, 1986, the number of students in any class in kindergarten through third grade in
11	any public city or parish school system shall not exceed twenty, except physical
12	education classes, unless otherwise specifically authorized in writing by the State
13	Superintendent of Education based upon regulations adopted by the State Board of
14	Elementary and Secondary Education. Such authorization shall be granted only on
15	an individual basis with respect to each class.
16	(2) Notwithstanding any other law to the contrary, on or after August 1,
17	2014, the number of students in any core curriculum class in a secondary school
