ARSON. Provides relative to the registration of arson offenders. (8/1/14)

1	AN ACT
2	To amend and reenact the introductory paragraph of R.S. 15:562.2, 562.3(B)(2), the
3	introductory paragraph of 562.4(A), and 562.6 and to enact R.S. 15:562.1(3)(i) and
4	562.2(B), relative to the registration of arson offenders; to provide relative to
5	definitions; to authorize the state fire marshal to promulgate rules; to increase the
6	duration of registration for certain offenders; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. The introductory paragraph of R.S. 15:562.2, 562.3(B)(2), the
9	introductory paragraph of 562.4(A), and 562.6 are hereby amended and reenacted and R.S.
10	15:562.1(3)(i) and 562.2(B) are hereby enacted to read as follows:
11	§562.1. Definitions
12	For the purposes of this Chapter, the following shall apply:

14	(3) "Offense involving arson" includes the following:

16	(i) Injury by arson (R.S. 14:51.1).

2	$\underline{\mathbf{A}}$. In addition to any other powers and duties conferred in this Chapter, the
3	state fire marshal shall:

6	accordance with the Administrative Procedure Act to implement the provisions
7	of this Chapter.
8	§562.3. Registration of arson offenders

11	(2) Every offender required to register in accordance with this Chapter shall
12	appear in person and provide the information required by Paragraph (1) of this
13	Subsection to the state fire marshal or his designee within thirty business days of
14	establishing residence in Louisiana, or if a current resident, within thirty business
15	days after conviction or adjudication if not immediately incarcerated or taken into
16	custody after conviction or adjudication. If incarcerated, once released from
17	confinement, every offender shall appear in person within thirty business days to
18	register with the state fire marshal or his designee pursuant to the provisions of this
19	Section.

21	§562.4. Duty of offenders to notify law enforcement of change of address,
22	residence, or other registration information
23	A. Those persons required to register pursuant to the provisions of this
24	Chapter shall appear in person at the fire marshal's office or his designee's office
25	within thirty business days of establishing a new or additional physical residential
26	address or of changes in information previously provided when any of the following
27	occur:

1	A person required to register pursuant to the provisions of this Chapter shall
2	comply with the requirement for five ten years from the date of initial registration
3	for a first offense and for the duration of the lifetime of the offender for a second or
4	subsequent offense, unless the underlying conviction is reversed, set aside, or
5	vacated.

DIGEST

Thompson (SB 388)

<u>Present law</u> provides for the definition of "offense involving arson", which includes the following offenses:

- (1) Aggravated arson (R.S. 14:51).
- (2) Simple arson (R.S. 14:52).
- (3) Simple arson of a religious building (R.S. 14:52.1).
- (4) Arson with intent to defraud (R.S. 14:53).
- (5) Communicating of false information of planned arson (R.S. 14:54.1).
- (6) Manufacture and possession of delayed action incendiary devices (R.S. 14:54.2).
- (7) Manufacture and possession of a bomb (R.S. 14:54.3).
- (8) Fake explosive device (R.S. 14:54.5).

<u>Proposed law</u> retains <u>present law</u> and adds the offense of injury by arson (R.S. 14:51.1) to the definition.

<u>Proposed law</u> authorizes the state fire marshal to promulgate rules and regulations in accordance with the Administrative Procedure Act to implement the provisions of the arson registry.

<u>Proposed law</u> authorizes the state fire marshal to appoint a designee to fulfill his responsibilities under the arson registry requirements.

<u>Present law</u> requires a person to register with the state fire marshal for a period of five years for a first offense.

<u>Proposed law</u> increases the duration requirement for registration <u>from</u> five years to 10 years from the date of initial registration for a first offense.

Effective August 1, 2014.
