TRAFFIC/VIOLATIONS: Prohibits the use of photo speed enforcement devices on interstates

1	AN ACT
2	To enact R.S. 32:43, relative to automated speed enforcement devices; to prohibit the
3	installation and use of automated speed enforcement systems on state highways; to
4	prohibit the imposition and collection of certain fines, fees, or penalties under certain
5	circumstances; to provide for definitions; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 32:43 is hereby enacted to read as follows:
8	§43. Automated speed enforcement devices; prohibition
9	A. Local municipal authorities or local parish authorities shall not install or
10	utilize automated speed enforcement devices to regulate traffic on interstate
11	roadways within their corporate or territorial limits.
12	(1) The provisions of this Section shall not apply to highway construction
13	zones where construction workers are present.
14	B. For the purposes of this Section, the term "automated speed enforcement
15	device" means an unmanned or handheld camera or optical device installed to work
16	in conjunction with a traffic control signal or radar speed detection equipment, or
17	both, and designed to collect photographic evidence of alleged traffic violations for
18	the issuance of traffic citations by recording images that depict the license plate or
19	other identifying feature of a motor vehicle not in compliance with instruction of a
20	traffic control signal or posted traffic sign.
21	C. Effective January 1, 2015, local municipal authorities or local parish
22	authorities shall not impose or collect any civil or criminal fine, fee, or penalty as a

Danahay HB No. 896

Abstract: Prohibits the use of photo speed enforcement devices on state maintained roads within the territorial or corporate limits of a municipality or parish.

<u>Proposed law</u> prohibits the use of automated speed enforcement devices by local municipal authorities or local parish authorities on interstate roadways within their corporate or territorial limits.

<u>Proposed law</u> excludes highway construction zones where construction workers are present.

<u>Proposed law</u> defines "automated speed enforcement device" as an unmanned or handheld camera or optical device installed to work in conjunction with a traffic control signal or radar speed detection equipment, or both, and designed to collect photographic evidence of alleged traffic violations for the issuance of traffic citations by recording images that depict the license plate or other identifying feature of a motor vehicle not in compliance with instruction of a traffic control signal or posted traffic sign.

<u>Proposed law</u> prohibits any local municipal authority or local parish authority from imposing or collecting any civil or criminal fine, fee, or penalty as a result of an image produced in violation of <u>proposed law</u> on or after Jan. 1, 2015.

Requires any local municipal authority or local parish authority to discontinue use of automated speed enforcement devices in violation of this Act by Jan. 1, 2015.

Effective upon signature of governor or lapse of time for gubernatorial action.
