SENATE CONCURRENT RESOLUTION NO. 1

BY SENATOR MILLS

PUBLIC HEALTH. Amends the communicable diseases reporting rules.

1	A CONCURRENT RESOLUTION
2	To amend the Department of Health and Hospitals, office of public health, rule LAC
3	51:II.105(A)(4), to provide for the reporting of certain communicable diseases and
4	conditions; to provide for the addition of Respiratory Syncytial Virus (RSV) to the
5	reporting list; and to direct the Louisiana Register to print the amendments in the
6	Louisiana Administrative Code.
7	WHEREAS, the Department of Health and Hospitals, office of public health,
8	promulgated a rule in 2002 providing for reportable diseases and conditions; and
9	WHEREAS, R.S. 49:969 provides that the legislature, by concurrent resolution, may
10	suspend, amend, or repeal any rule adopted by a state department, agency, board, or
11	commission; and
12	WHEREAS, the purpose of this Resolution is to add an additional communicable
13	disease/condition that shall be reported to the Department of Health and Hospitals, office of
14	public health.
15	THEREFORE, BE IT RESOLVED by the Legislature of Louisiana that LAC
16	51:II.105(A)(4) is hereby amended to read as follows:
17	§105. Reportable Diseases and Conditions
18	A. The following diseases or conditions are hereby declared reportable with

1	reporting requirements by Class.
2	* * *
3	4. Class D Special Reportable Diseases or Conditions Shall Require
4	Reporting within Five Business Days
5	a. This class shall include the diseases of significant public health concern.
6	The following diseases/conditions shall be reported to the Office of Public Health by
7	the end of the workweek after the existence of a case, suspected case, or a positive
8	laboratory result is known:
9	i. Cancer;
10	ii. Monoxide exposure and/or poisoning;
11	iii. Complications of abortion;
12	iv. Congenital hypothyroidism ⁴ ;
13	v. Galactosemia ⁴ ;
14	vi. Heavy metal (arsenic, cadmium, mercury) exposure and/or poisoning (All
15	Ages) ⁵ ;
16	vii. Hemophilia ⁴ ;
17	viii. Lead exposure and/or poisoning (children) ⁴ ; (adults) ⁵ ;
18	viii <u>ix</u> . Pesticide-related illness or injury (all ages) ⁵ ;
19	$\frac{1}{2} \mathbf{x}$. Phenylketonuria ⁴ ;
20	x <u>xi</u> . Reye's Syndrome;
21	xi <u>xii</u> . Severe traumatic head injury;
22	xii xiii. Severe under nutrition (severe anemia, failure to thrive);
23	$\frac{\mathbf{xiii}}{\mathbf{xiv}}$. Sickle cell disease (newborns) ⁴ ;
24	xiv <u>xv</u> . Spinal cord injury;
25	xv xvi. Sudden infant death syndrome (SIDS);
26	xvii. Respiratory Syncytial Virus (RSV).
27	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
28	office of the state register and the Department of Health and Hospitals, office of public
29	health.

- (1) Cancer.
- (2) Monoxide exposure and/or poisoning.
- (3) Complications of abortion.
- (4) Congenital hypothyroidism.
- (5) Galactosemia.
- (6) Heavy metal (arsenic, cadmium, mercury) exposure and/or poisoning (All Ages).
- (7) Hemophilia.
- (8) Lead exposure and/or poisoning (children); (adults).
- (9) Pesticide-related illness or injury (all ages).
- (10) Phenylketonuria.
- (11) Reye's Syndrome.
- (12) Severe traumatic head injury.
- (13) Severe under nutrition (severe anemia, failure to thrive).
- (14) Sickle cell disease (newborns).
