## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The DOA indicates the proposed bill will require one time costs of \$941 for programming and vendor (LA Engineering Society) setup in the state's payroll system and annual processing costs of approximately \$500 for a total cost of \$1,441. This anticipate payroll system cost is not based on a per deduction basis. Whether 1 person or 100 individuals deduct membership dues, the total anticipated cost to the DOA will be \$1,441.

The Legislative Fiscal Office believes that any additional programming costs associated with this bill will be incremental in nature and that the DOA can potentially accomplish these tasks utilizing existing resources and budget authority. To the extent that numerous pieces of legislation are enacted that require additional HR programming costs associated with other payroll deductions, the DOA may require additional resources.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
