HOUSE RESOLUTION NO. 2

BY REPRESENTATIVES HENSGENS AND CHAMPAGNE

TRANSPORTATION: Urges and requests the Department of Transportation and Development to study and make recommendations relative to a hurricane evacuation route for and economic development of a certain portion of La. Highway 330.

1	A RESOLUTION
2	To urge and request the Department of Transportation and Development to conduct a study
3	and make recommendations relative to a hurricane evacuation route for and
4	economic development of Louisiana Highway 330, south of Abbeville through
5	Henry, as well as providing a turning lane at the major economic development site.
6	WHEREAS, the maintenance of roads and highways is of great importance to the
7	state of Louisiana; and
8	WHEREAS, Louisiana Highway 330, from the city of Abbeville to the town of
9	Henry, is a major thoroughfare in the parish of Vermilion, and is in need of significant
10	maintenance and overlay; and
11	WHEREAS, Vermilion Parish sustained significant flood and wind damage from
12	Hurricanes Katrina and Rita in 2005, and a hurricane evacuation route is vital to emergency
13	preparedness; and
14	WHEREAS, providing a turning lane at this site will alleviate congestion and aid in
15	traffic flow during hurricane evacuation.
16	THEREFORE, BE IT RESOLVED that the House of Representatives of the
17	Legislature of Louisiana does hereby urge and request that the Department of Transportation
18	and Development conduct a study of Louisiana Highway 330, south of Abbeville through
19	Henry, and make recommendations regarding a hurricane evacuation route, economic
20	development, and providing a turning lane at the major economic development site.

1 BE IT FURTHER RESOLVED that the study by the Department of Transportation 2 of Development should consider assessments of the following: (1) all safe and practical 3 modes of transportation available for evacuations, including contraflow; (2) the extent to 4 which evacuation plans are coordinated with adjoining jurisdictions; (3) methods of communicating evacuation plans and preparing citizens in advance of evacuations; (4) 5 6 methods of coordinating communication with evacuees during plan execution; (5) the 7 availability of food, water, restrooms, fueling stations, and shelter opportunities along 8 evacuation routes; and (6) the time required to evacuate under the plan. 9 BE IT FURTHER RESOLVED that the Department of Transportation and

10 Development shall make a written report to the Louisiana House of Representatives detailing

11 their findings no later than January 1, 2015.

12 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the

13 secretary of the Department of Transportation and Development.
